Discussion of un-paid dues:

Unanimous decision to impose \$5.00 late fee for each month a homeowner has not paid their dues effective April 1, 2020. The late fee will be applied each month. (the late fee is to cover the cost of sending additional billing invoices to the homeowner.)

There are 30 homeowners who have not paid their required \$89.00 Annual Dues. Roiann will send out a 2nd billing to all past-due accounts with an invoice. The March, 2020 billing will

notify each homeowner that if they do not pay the \$89.00 dues, beginning April, 2020 they will be charged \$5.00 every month until their dues is paid in full, including late fees.

Discussion of Design & Review Committee referral of infraction:

Design & Review members have contacted the Board of Directors regarding a shed that has been placed on a property without going through the required approval process. This is a new homeowner to Crestridge Estates, because the homeowner did not follow CC & R's or By-Laws before getting approval from the Design & Review Committee, the position/placement of the shed is in violation of CC & R's. The infraction/violation is now a BOD issue that needs to be resolved in an orderly and neighborly manner.
