## AMENDMENT TO THE DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS, AND RESTRICTIONS OF THE CRESTRIDGE SUBDIVISION

The Declaration of Protective Covenants, Conditions, and Restrictions ("CC&R's) for the Crestridge Estates was originally adopted in July of 1992 and recorded as document number 93-11867 in the Official Records of Deschutes County, Oregon.

## RECITALS

WHEREAS, the Declaration of Protective Covenants, Conditions, and Restrictions for the Crestridge Estates provided that such Declaration is set to expire after a period of thirty (30) years from the date of such Declaration. This date is on or about, July 31, 2022; and,

WHEREAS, the Declaration of Protective Covenants, Conditions, and Restrictions provide that such restrictions may be extended by recording a written instrument showing sixty percent (60%) or more of the Crestridge Subdivision lot owners, have approved an extension of the CC&R's; and,

WHEREAS, forty-eight (48) of the seventy-two (72) Crestridge Subdivision lot owners have consented to extend the CC&R's for a period of five (5) years from July 31, 2022 to July 31, 2027; and,

WHEREAS, all of the signed votes are on file with the Secretary of the Crestridge Homeowners Association (HOA) and are available for viewing by written request.

NOW THEREFORE, in consideration of the foregoing, a majority of the owners of the lost in the Crestridge Subdivision have adopted an Amendment to extend the CC&R's for a period of five (5) years beginning July 31, 2022, to July 31, 2027. The tally of all signatures for the vote on this amendment is attached hereto as "Exhibit A".

## AMENDMENT

The Declaration of Protective Covenants, Conditions, and Restrictions ("CC&R's) for the Crestridge Estates is hereby amended to extend the CC&R's for a period of five (5) years from July 31, 2022, to July 31, 2027.


