## PROTECTIVE COVENANTS, CONDITIONS AND RESTRICTIONS FOR CRESTRIDGE ESTATES

THIS ADDENDUM amends the Declaration of Protective Covenants, Conditions and Restrictions for Crestridge Estates dated July, 1992, and recorded in the Deschutes County Official Records in Book 295, Page 2527, on April 15, 1993. The owners of the lots comprising the Crestridge Subdivision hereby adopt the following amendments:

## SECTION ONE

Article IX, Section 6 is amended to add Section (C) as follows:

- A. Unless extended, revised or repealed, these CC&R's shall expire after thirty (30) years.
- B. These CC&R's may be extended by recording, within sixty (60) days of the expiration date, a written instrument, signed by sixty percent (60%) or more of the subdivision lot owners, which states their intention to extend the CC&R's life. Any extension must be for a minimum of two (2) years and a maximum of ten (10) years. The same procedure shall apply for successive extensions.
- C. These CCAP's may be amended at a meeting of the members of the Association provided seventy-five percent (75%) of the Owners of the lots (1 vote per lot) voting for the amendment do so affirmatively. Members may vote by proxy. Such a vote shall only occur, however, if written notice of the meeting and the amendment to be voted on is sent to the Owners at least thirty (30) days prior to the meeting.
