## CRESTRIDGE ESTATES - Bylaws and CCR's Modification - Voters Guide

Following is a guide intended to highlight what's at stake in next meeting's vote.

Both the Bylaws and CCRs contain many elements. MOST of these elements, thankfully, are benign; that is neither controversial nor divisive. They are covered in the full text but are not repeated in this guide.

What is listed below are well known issues that previous canvassing has shown to be of importance to Crestridge homeowners.

They are listed in the same order as they appear in the full text. Their location is also cited. TO BE FULLY INFORMED, EVERY VOTER IS ENCOURAGED TO READ THE FULL TEXT OF THE PROPOSED DOCUMENTS.

HOWEVER, Homeowners need to know what they're voting on, what their vote means and they should not need to ferret out the principle issues. So we've done it for you. In short, the elements below are those upon which the Vote is expected to ultimately swing.

If you vote YES you are voting to approve the entire package of Bylaws and CCRs as modified and presented.

A NO vote would return Crestridge to its present set of Bylaws and CCRs – and we have to start over.

## The highlights of the proposed modifications are listed below:
