PRIVACY NOTICE

As a subscriber to our cable service you are entitled to certain privacy rights under the federal Cable Act which generally is Title VI of the Communications Act of 1934, as amended The Cable Act, particularly Section 631, restricts the ways in which we, as your cable system operator, may collect retain and disclose personally identifiable subscriber information, and the Cable Act requires us to inform you annually of those restrictions and your rights and remedies.

- 1. In order that we may provide reliable, quality service to you, and to make sure that you are being properly billed for the services you receive, we keep regular business records relating to you as a subscriber. The personally identifiable information included is your name, spouse's name, phone number, identification card numbers (such has driver's license and/or social security number), credit card information (as required for payment for services), records relating to deposits (if any), cable service and installation agreements, work orders, billing and payment information, service options you have chosen, the number of television sets in your household connected to our service, and service calls, repairs, maintenance and complaints.
- 2. We consider this personally identifiable information to be confidential, and may disclose it to a third party only if (a) disclosure is necessary to render cable service or other services we provide to you, or for related business activities (as described in Paragraph 3, below): or (b) disclosure is required pursuant to a court order: or (c) you consent in advance. We likewise take such as actions as are necessary to prevent unauthorized access to your personally-identifiable information by persons other than you or us, including protection such information from unauthorized disclosure in connection with any wire or radio communications service provided over the cable television facilities used to provide you cable service.
- 3. All personally identifiable information is used only for the normal business purpose of offering and rendering cable service to you. Such information is collected and used for billing and collection purposes, programming, marketing and other cable-related aspects of providing, auditing and maintaining your service, and for keeping legal, financial, accounting, tax and property records, as well as specific records required by the terms of our cable television franchise. It is accessible only as often as needed (which could be on a day-to-day basis) to: cable system employees, contractors and installation and sales agents to install, market, provide and audit cable services, and to measure viewership and subscriber satisfaction; business which proved services to us (such as our accountants, attorneys, billing and collection services); potential purchasers in connection with a system sale; tax professionals and bookkeepers to compile records and file reports; outside auditors to verify records: program guide providers, where applicable; program services for marketing and audit purposes. The frequency of disclosure varies according to our business needs, and may be on a day-to-day basis.
- 4. Personally identifiable information may be obtained from us by the government pursuant to a court order, but you must first be afforded the opportunity to appear in court and contest the government's claim for disclosure. We are required to notify you if a court orders us to disclose such information concerning you.

From time to time, we receive requests from charities, direct order retailers or others to disclose your name and address to them. Under the Cable Act it is permissible to disclose such information if we have given you prior opportunity to prohibit or limit such disclosure and you have not done so. However, it is our policy not to disclose personally identifiable subscriber information to any one for any purpose not related to our business. We may not disclose the extent of your viewing or use of particular service or the nature of any transaction you make over the cable system under any circumstances.

You have the right to inspect and request correction of any error in our records that contain information about your. If you wish to inspect your records, please contact us by mail or telephone at our office giving us a reasonable period of time to locate and, if necessary, prepare the information for review, and to arrange an appointment during our regular business hours. 7. All personally identifiable information will be destroyed when it is no longer needed for the purpose for which it was collected, unless there is a pending request by you to examine the information about you or a pending court order with respect to the information, in which event the information will be destroyed as soon as the request or order has been complied with. We will maintain personally identifiable information about you as long as we provide service to you and for three years thereafter in order to comply with applicable laws, and for related business activities, such as for follow-up billing, tax and accounting purposes.

8. In addition to any other rights or remedies, which may be available to you, you may bring a civil action against us in federal court to enforce your privacy rights under the Cable Act. The court may award actual or liquidated damages, punitive damages and reasonable attorney's fees and litigation costs incurred by you.
