## **CONTRACT AGREEMENT**

Lessee acknowledges receipt of the described personal property. The parties agree that the property was inspected by Black Star and personally examined by Lessee at the time of delivery to and acceptance by Lessee and that the property was in good and serviceable condition.

Title to the rented property is, and at all times shall remain in Black Star. Only the parties hereto and such other persons whose names are endorsed hereon are authorized to use said property, and Lessee will not permit said property to be used by any other person or at any address other than the place designated hereon without the express consent of Black Star.

Parties agree that Black Star is not the manufacturer of said property nor the agent of the manufacturer and that no warranty against patent or latent defects in material, workmanship or capacity is given.

Lessee agrees that in the event any of the property becomes unsafe or in a state of disrepair, Lessee will immediately discontinue the use thereof and promptly return it to Black Star. Upon receiving such property, if its condition is not the fault of the lessee, Black Star agrees to replace such property with property of like kind and in good working condition.

Upon termination of this agreement, lessee will promptly return the rented property and all attachments and parts belonging thereto, to the Black Star at Black Star's place of business, in the same condition In which such property was received, ordinary wear and tear expected, and agrees 10 pay for any damage to or loss of such property while in the possession or control of Lessee hereunder. In the event that Black Star must resort to litigation to recover for damages caused to or loss of such property. Lessee also agrees to pay Black Star's reasonable attorney fees and Court costs.

Black Star shall not be liable in any event to lessee for any loss, delay or damage of any kind of character resulting from defects in or inefficiency of the leased property or accidental breakage thereof.

Lessee agrees to indemnity and save harmless the Black Star against all loss, damage, expense and penalty arising from any action on account of any injury to person or property of any character occasioned by the operation, handling or transportation of the leased property during the rental period or while the property is in the possession or control of Lessee.

Lessee will give Black Star immediate notice of any levy attempted upon said property, or if said property from any cause becomes liable to seizure, and to indemnify Black Star against all loss and damages caused by any such action, Including Black Star's reasonable attorney's fees and expenses.

Lessee will not retain the leased property beyond the "Due In" time without prior notice to and the consent of Black Star thereto, Lessee will pay rental price in advance of immediately upon the return of property. Lessee agrees to pay all collection charges, including a reasonable attorney's fee, if the rental is not paid when due.

Black Star, at Black Star's sole discretion may report property stolen if held (3) days beyond "Due In" date. Black Star at Black Star's sole discretion, may revert all charges to the daily rate if any monthly statement or invoice is not promptly paid. Black Star will not refund on any item out over (30) minutes. Black Star will extend credit for like amount on any item providing Lessee uses this credit within a period of (15) days from the out date of Contract.

Lessee hereby waives and releases Black Star from all claims for injuries or damages to Lessee arising out of the use of said property by Lessee.
