Subject: Request for Investigation into Misconduct by Attorney Alexander Hilding Beck

Dear Intake Counsel,

Intro

In May 2020, I was in a car accident and I hired lawyer Marc Shuman to represent me. Shortly after, IDHFS placed a lien on my insurance claim for past-due child support arrears caused by misconduct by Alex Beck. I contacted Alex Beck for representation to remove the lien he caused, his office claimed a conflict of interest.

Background

I initially engaged Mr. Beck in 2007 during a reduction of child support payments, and contempt proceedings with threat of jail, expecting diligent and ethical legal representation. Unfortunately, his handling of my legal matters has consistently fallen below acceptable professional standards, leading to severe personal and financial consequences.

March 10, 2008: I was found in willful contempt of court and sentenced to 60 days in jail with bail set at \$5,000 due to Mr. Beck's inadequate representation.

July 30, 2008: While in custody, Mr. Beck represented me during a status hearing on my ability to post bail. The court reduced my bond from \$5,000 to \$1,000, which I posted to purge the contempt charge.

August 13, 2008: The court ordered the turnover of the \$1,000 bond I posted to the plaintiff, further exacerbating my financial difficulties. Mr. Beck did not effectively contest this decision.

2007 to 2021: Mr. Beck's actions resulted in the issuance of over 132 income withholding notices that mischaracterized me as a 'deadbeat dad,' causing significant financial hardship and damage to my reputation.

From 2006 to 2021, the Illinois Department of Healthcare and Family Services (IDHFS) issued over 132 income withholding letters, defaming me a “deadbeat dad” in error to the public and the Treasury Department while garnishing my money.

The misconducts by Alex caused

In 2012, there was a cover-up involving Judge Allen who my ex-wife Michelle Bough Dello clerked for while in relationship with judge Joseph C Polito, that Alex knew about proven by my 2009 JIB filing in 2006D1237.

Alex Beck, like Marc Shuman, sets his clients' matters up for failure. If Alex had performed a reduction, there would be no lien on Travelers Insurance claim no. IFX-8179. I am presenting this lien as evidence of Alex Beck's misconduct, along with the phone call I had with Travelers Insurance on 6/24/2022.

If Alex had done the reduction in 2007, there would be no lien on the claim, and Marc Shuman would not have set my matter up for failure. Similarly, Jerry would not be biased, and my father would not have set up the 2018 SNT trust. The illegal IDFHS bank levy in 2018 caused my father, Raymond Motta, to hire Jerry, who advised my father that Chase Bank broke the law and that I was entitled to at least \$1,000 in living expenses.

After my father passed, Jerry exploited the IDHFS debt to defraud the SNT trust he created. This is further evidence of fraud by Jerry, which was ultimately caused by Alex's failure to perform the reduction in 2007. This version maintains the original meaning while improving clarity and readability.

Today, Alex's misconduct is exacerbating the situation, causing lawyers like Jerry Goergen to act irrationally and enabling the theft of my inheritance by Jerry and Jamie Shimer.

This has resulted in the defrauding of my Special Needs Trust (SNT) and ongoing financial abuses. Alex's actions have led to Jerry Goergen and Jamie Shimer not adhering to my father's directives.

Jerry advised my father that the actions by IDHFS, which caused a bank levy and left a negative balance with not even \$1,000 for living expenses, were illegal. If Alex had made the necessary reductions, my inheritance would not be at risk today.

Because of Alex's misconduct, I have suffered with ruined credit and forced into bankruptcy by Alex Beck not doing his fiduciary duties, 2008 by doing a reduction.

High-interest credit cards and poverty have needlessly impacted my life due to Alex's misconduct during a period when I was raising my two children.

As a result of Alex's misconducts, my children's upbringing was ruined. At that time, I was also involved in anti-aging research and paying for Viacord and Palm Beach rejuvenation treatments. Alex disrupted my anti-aging treatments and my ability to pay for Viacord, which remains a serious issue today.

This is another reason why the Illinois Attorney Registration and Disciplinary Commission (IARDC) should discipline Alex. Additionally, Alex caused side effects from unnecessary

medications that could have killed me, similar to what happened to my mother, whose wrongful death was due to medical errors.

The misconducts by Alex are currently obstructing my access to my father's medical records due to an illegal debt accrued by the Illinois Department of Healthcare and Family Services (IDHFS), which also affected my Special Needs Trust (SNT).

This situation has led my brother Rick to withhold my father's medical records. The defamation and slander by IDHFS have convinced him that I am incapable of managing money, resulting in his abusive behavior. His belief that I cannot handle finances is detrimental, especially since, in the real world, money is essential for paying bills. This is how Rick and Jerry are exploiting me to defraud my SNT trust, exacerbated by Alex's failure to reduce child support payments in 2008.

Jerry's financial exploitation continues to harm my SNT trust, similar to lawyer Jamie Shimer's biased and conflicted actions upon learning about the illegal IDHFS debt. Others do not understand that child support arrears debt is no ordinary debt. Even Shuman Legal's Wanda Rivera stated that it's a super lien, and nothing Shuman Legal can do will remove the illegal lien on my insurance claim.

Due to Alex's failure to reduce my child support payments in 2008, Rick has threatened to give my entire inheritance to my ex-wife. Recently, I discovered that my ex wife Michelle's new husband Marty Dello is in bankruptcy because of Alex Beck's misconducts by not doing a reduction in 2008.

After seeking medical advice, I realized how Alex Beck's negligence in not lowering my child support payments in 2008 led to a series of health issues and PTSD, a form of legal abuse syndrome. Dr. Karin Huffer diagnosed this condition amidst a fraudulent divorce and unlawful detention in 2008. This has persisted due to doctors' misdiagnoses, leaving me without proper treatment for the ongoing legal and financial abuses and symptoms I continue to endure because of Alex's misconduct.

Alex's misconduct has caused significant financial anxiety and countless sleepless nights for me. Additionally, Marc Shuman defrauded me of over \$46,500 in my car accident personal injury claim. The situation deteriorated further when Marc charged excessive court costs for filing a lawsuit against the wrong defendant, failed to serve notice, and caused a DWP by Judge Roger Rickmon. I had to purchase court transcripts that prove the judge was biased and conflicted, all of which were repercussions of Alex's actions. This continues to tarnish my reputation and results in biased and conflicted behavior from judges, causing serious harm to my insurance claim.

IDHFS lien on Travelers Insurance's claim also points to Alex as the root cause of my insomnia, the "Shuman migraine," and being forced to represent myself due to his failure to act in 2008—a time when I trusted and relied on him to do a reduction in child support payments. Simply, if Alex did a reduction, there would be no lien on insurance claim.

Lawyer Michael A. Lew's actions caused to a nervous breakdown, chronic financial anxiety disorder, undergoing two divorces simultaneously, losing my business, and losing custody of my son during my divorce from Michelle on grounds of mental cruelty.

The most significant harm a lawyer could inflict, as demonstrated by Alex and Michael Lew, was causing an illegal IDHFS debt that has severely impacted my life, contrary to why I hired Alex Beck.

The ongoing financial and legal abuses persist due to Alex's misconducts. The Treasury Department is responsible for my refund and retroactive credit. The Title IV-D crime family should not be rewarded for their fraud, nor should Judge Joseph C. Polito, known as "Pornlito" in 2012.

Bribery is illegal, and the IDHFS debt is based on fraud and bribery. Today, I have a \$0 order, but the damage has been done, which is why I am owed a retroactive credit. I will contact Congresswoman Lauren Underwood and rewatch Amen Osiris' videos on laws. IDHFS should not be rewarded for their fraud.

2021: I had to present evidence to the Illinois Department of Healthcare and Family Services (IDHFS) administrative judge to rectify an illegal lien on my car accident claim, which should have shown a \$0 balance. Mr. Beck's failure to address this issue indicates willful neglect and ongoing legal manipulation.

Today, I am facing multiple issues with ViaCord due to Alex's misconduct, including complications with my children's and family's medical forms and the use of stem cells for my car accident.

No lawyer seems to know how to handle the situation because of Alex. My recent phone calls with lawyers have been unproductive, and the bill is overdue. Additionally, Michelle has not returned my calls. If I lose the ViaCord services, Alex will be held responsible.

Ongoing lawfare and lawyers setting my legal matters up for failure making simple legal matters complex like Alex did in 2008, 2012 cover up judge Allen, who my ex-wife clerked for while working at the Will County Illinois courthouse.

Key Allegations and Timeline of Misconduct

On March 10, 2008, I was found in willful contempt of court and sentenced to 60 days in jail, with bail set at \$5,000, due to Mr. Beck's inadequate representation.

Lawfare and Financial Exploitation by Lew (2006-2007)

The legal proceedings initiated due to the theft of \$2,000 by Michael A. Lew have had significant repercussions. If Mr. Lew had refunded my \$2,000, I would not have encountered Alex Beck, and my health and relationship with my children would have remained intact.

Failure to Reduce Payments and Resulting Debts (2006-2021)

Mr. Beck failed to pursue a reduction in child support payments, leading to the accumulation of illegal IDHFS debt over time from 2006 to 2021. This negligence resulted in a lien on my car accident claim and other financial burdens.

Health and Financial Impacts

Mr. Beck's misconducts have caused serious health issues, including PTSD and severe depression, leading to needless poverty and daily headaches. These conditions have taken years off my life.

Financial Hardship and Quality of Life

If I had access to the money stolen by IDHFS, I could have enjoyed a \$100K per year salary, providing a better quality of life and raising my children in a nice home instead of a living in a basement with relatives.

Failure to Report Lew's Misconduct (2006)

If Michael Lew had refunded the \$2,000, there would have been no fraudulent divorce case in Will County, Illinois (case number 06D1237). Despite being aware of my 2006 draft complaint against Lew, Mr. Beck failed to report Lew's misconduct to the IARDC.

Knowledge of Fraudulent Debt (2004-2008)

Mr. Beck was aware of case 04D871 and knew that the debt was based on fraud and a void order. Instead of submitting evidence to a judge in 2008, he left me to face threats alone in 2020 during an administrative hearing where I had to submit evidence pro se while undergoing treatments for painful injuries from a car accident.

By failing to present evidence in 2008 that the debt was fraudulent and the order was void, Mr. Beck neglected his duty as my attorney. This forced me to represent myself pro se and submit evidence during an administrative hearing in 2020, while I was still recovering from injuries sustained in a car accident. His inaction in 2008 left me to face threats alone and navigate legal proceedings without counsel during a difficult time.

Coercion and Legal Harassment (2006-2021)

Mr. Beck's actions caused coercion and a constant threat, comparable to having a gun to my head from 2006 until the illegal lien was removed in 2021.

Due to Mr. Beck's failure to secure a reduction, my inheritance has been stolen, and I require an abuse therapist today. His negligence has resulted in severe financial and emotional harm.

Specific Allegations of Misconduct

Legal and Financial Misconduct

Professional Negligence and Entrapment

Mr. Beck failed to pursue reductions in my child support payments despite evidence that my annual income was well below \$100,000 from 2006 to 2012, which was contrary to Illinois child support statutes at that time.

.Health Impacts

Alex's Misconduct causing Medical Misdiagnosis: In 2010, Alex's misconduct led to a misdiagnosis during an ER visit, causing severe side effects that could have been fatal. The Illinois Department of Public Health, much like the IARDC, failed to address this issue.

Chronic Financial Anxiety: My chronic financial anxiety caused by misconducts by Alex is preventing me from starting a water fast today and interfering with ongoing car accident treatments like Marc Shuman who set my insurance claim up for failure because of Alex's failure to do a reduction in 2007, a series matter today in 2024, and ongoing into my future, the damage has been done, I am owed millions of dollars caused by Alex, and no way to get financial

Like legal and financial abuse therapist Mario, who was referred for treatment for my car accident injuries, said, the illegal lien by IDHFS has caused additional anxiety on top of my painful injuries. Others do not realize all the pain and suffering caused by Alex. His actions led to severe depression and unnecessary medication while I was raising my children. This situation caused my children to believe I owed past-due child support, enabling Michelle to alienate them from me. It also delayed my ability to file an abuse report and deal with Pornlito in 2009.

Ongoing misconduct by Alex has interfered with both my cancer treatments and car accident injury treatments, including water fasting and physical therapy, which requires focus and attention that I can't maintain while dealing with fraud by my own lawyers. Lawyers like Marc Shuman, whose IARDC rule violations have caused me sleepless nights, anxiety, high blood pressure, and consumed my time, forced me to go pro se despite not being a lawyer. These experiences highlight the importance of hiring a lawyer who works for you, not against you.

The anxiety stemming from Alex's failure to secure a reduction is causing severe stress, similar to the issues caused by Marc. In functional medicine terms, the root cause of my anxiety is Alex's failures. Additionally, if Michael A. Lew had refunded my \$2000, I would never have had to deal with Alex. His failure to secure a reduction in 2007 led to fraud, legal malpractice, and the theft of my inheritance by Jerry, Jamie, and my brother Rick. If Alex had acted correctly in 2007, I wouldn't be facing these legal issues today.

Alex's Character and Professional Failures: If Alex set my legal matters up for failure, violating his oath and duties owed to me as a client, he will do the same to you. This speaks volumes about Alex's character; he is a dishonest fraud, the worst type of lawyer who sets clients up for failure while charging them money.

Warning About Alex: If Alex set my legal matters up for failure, he is an unethical lawyer who will do the same to your legal matters. When facing jail, remember that Alex is a lawyer not to hire, a deadbeat lawyer, similar to Marc Shuman and Jerry Goergen.

The continuous legal battles and financial pressures directly contributed to my deteriorating health, requiring extensive and costly medical treatment.

Requested Actions

Conduct a comprehensive investigation into these allegations against Mr. Beck to assess any breaches of legal and ethical standards.

Conclusion

The gravity of these allegations and their profound impact on my life necessitate a prompt and thorough review by the IARDC. Upholding the integrity of the legal profession and ensuring justice requires decisive action.
