He failed to consult with me, his client, and did not explain his valuation of only \$46,500 in his demand letter. His demand letter did not reflect my car accident injuries and set my legal matter up for failure, as proven by a recorded phone call with Travelers on 6/24/2022.

Marc Shuman also filed a lawsuit against the wrong person, failed to serve notice on Travelers Insurance and Abigail Bird (the defendant), causing a DWP (Dismissal for Want of Prosecution) by Roger Rickmon. This caused me sleepless nights, high blood pressure, and additional medical bills. Marc's actions added stress and anxiety, causing me to miss physical therapy for my knee injury. He even made up defamatory letters about me, robbing me of my time to draft bill disputes and cease-and-desist letters.

2. The Unethical Lawyer

Red Flags:

- Fraud and Misrepresentation: Marc Shuman engaged in fraud, breaching our contract to negotiate and settle out of court. He lied about me on paper, defaming me. The fact that Marc set my legal matter up for failure, as proven by clear evidence, is proof of his unethical behavior. I had to spend my time filing a valid complaint with the Illinois Attorney Registration and Disciplinary Commission (IARDC) against Marc. The IARDC's failure to address my allegations properly is egregious, forcing me to send a certified letter to the director of the IARDC to file a complaint against James Needles.
- Conflict of Interest: Marc's actions showed a clear conflict of interest, as he was more interested in his gain than my well-being.

Reasons to Avoid:

- Breach of Duty: Marc Shuman defrauded me out of over \$46,500, as proven by the DWP issued by Judge Roger Rickmon. He failed to fulfill his duties as my lawyer, resulting in a \$0 attorney bill/lien that he refused to provide in a timely manner, preventing me from negotiating and settling out of court.
- Time and Financial Loss: Marc is a time bandit and a thief. His negligence and incompetence forced me to spend more time and money correcting his mistakes. He added unnecessary stress and anxiety, causing me to miss crucial medical treatments.
