

In case you want to download a blank form used for notice of transfer of ownership of a motor vehicle to the Regional Transport Office (RTO) to furnish it in offline mode, you can do so from Parivahan Portal. Let us check the steps to download the blank form in PDF format. Visit Select 'Informational Services' from the main menu. Hover over "Downloadable Forms" on the drop-down Select "All Forms" & you will be redirected to a page with all RTO Forms. Click "Form 29" against the 'Vehicles Related' category of forms. Your form will be downloaded in PDF format. The purpose of this form is to inform the registering authority about the transfer of ownership of a vehicle and to obtain their endorsement for the same. In order to complete the form, there are certain steps that must be followed.

These steps ensure that all necessary information is provided and that the form is filled out correctly. In the following steps, we will take a detailed look at how to fill out Form 29: Start by writing the name of the Registering Authority in the space provided at the top of the form. In the next section, fill in your personal details including your name, address, and contact information. Mention the date on which you sold the vehicle and provide the vehicle's make, chassis number, and engine number or motor number in the case of Battery Operated Vehicles. Fill in the details of the transferee including their name, relationship (if any), address, and signature or thumb impression. Provide the details of the agreement of hire/purchase/lease/hypothecation with the financier. In the section for the financier, provide their signature and date of consent. As the transferor, sign the form and provide the date of transfer. The form should be sent to the Registering Authority by registered post/acknowledgment due. The Registering Authority will endorse the form to confirm the transfer of ownership and return a copy to the transferor. Please Note: Make sure that all information provided is accurate and up-to-date, and any inaccuracies or suppression of information could result in legal consequences. To accompany the RTO Form 29 (Notice of Transfer of Ownership of a Motor Vehicle), the following documents are usually required: The original registration certificate of the vehicle, The original insurance certificate of the vehicle, A consent letter from the financier (if applicable), An agreement of hire/purchase/lease/hypothecation (if applicable), Proof of residence of both the transferor and the transferee, Signature or thumb impression of the registered owner (transferor), Signature of the transferee. Please Note: The documents required may vary based on the specific case and jurisdiction, and it is advisable to check with the local RTO for any additional requirements.

The owner gets the permanent registration number from the Telangana RTO within the stipulated time period. Permanent Registration Telangana RTO provides the vehicle owner with a form that the owner has to fill and submit after which the department issues him the permanent registration number. Ownership Transfer There is a way to transfer the ownership of a vehicle to someone else. For this, one has to fill form 30. An NOC and Form 35 is also required in case the vehicle is purchased through finance. Duplicate Registration In case the RC of a vehicle is lost, an FIR has to be filed in the nearby police station. A copy of the FIR along with an application must be submitted to either RTO or Motor Vehicle Inspector for issuing duplicate registration. Renewal of Registration Prior to 60 days of the expiry of an RC certificate, the owner must submit the required documents at the TS RTO. The documents include Form 25, the PAN card copy of the owner or Forms 60 and 61, car insurance policy, fitness and registration certificate and the vehicle's PUC. Transfer of RC in Case of Death If the owner of the vehicle dies, transferring of RC can be done. For this, the new nominee has to submit Forms 30 and 31 along with the KYC documents of the new nominee. The death certificate of the owner and the ID and address proof must also be submitted. If there is no nominee, the legal successor has the right to claim for the transferring of RC by filling the application form. Ownership Transfer to Another State The Form 29, NOC, and other required documents collected from the present state must be submitted at the Telangana RTO office in case of a change of state registration number from any other state to Telangana.
