Ballot Propositions:

Prop 1: ASD \$63,822,000 in general obligation bonds.

Prop 2: ARDSA \$33,700,000; increase tax cap \$143,000 annually.
Prop 3: Parks & Rec \$8,250,000; increase tax cap \$245,000 annually.
Prop 4: APD Service Area \$3,400,000; in general obligation bonds.

Prop 5: Public Safety CIP \$9,400,000; increase tax cap \$152,000 annually.

Prop 6: Senior Center & Libraries CIP \$2,800,000.

Prop 7: AFD Service Area \$2,400,000 general obligation bonds.

Prop 8: Girdwood Service Area Bonds \$3,000,000.

Prop 9: Chugach State Park Access Service Area Bonds \$300,000.

Prop 10: ARDSA Snow Response and Fleet Vehicle Special Tax Levy \$3,500,000 annually.

Prop 11: APD Vehicle Special Tax Levy \$3,500,000 annually.
