- The most important rezone set to be voted on Monday. Assembly by next Tuesday-ish.
- Local issues:
 - We won the case with Superior Court on Hulquist Subdivision;
 - Turned back to the Board of Adjustment
 - Rules have changed;
 - Our notice of appeal back in 2021; went to Superior Court; back to Board of Adjustment; appeals have to be sent to the Office of the Attorney (Dean Gates) (Assembly office); Michael Rose allowed the appeal to be reinstated; have until July 20th to file any changes; need to file the same doc for the 3rd time
 - Once you win a case, you have a right to file a cost bill with affidavit with costs; Joan is gathering costs tho the judge denied the cost reimbursements; Joan is arguing with the judge on the costs
- D. Ad-Hoc Hillside Protection Committee (Weddleton, June, Monette)
 - Unsure of Mills Subdivision Status; may have gone back to the Platting

VIII. Old Business

- A. HOMES 2023-87S update and AO 2024-45 Mark June
 - On the agenda for Assembly this Tuesday
 - 2025 is "the assembly can do whatever it wants regardless of existing zoning, etc."
 - It's important for people to consider talking points along the lines of:
 - Underlying assumption this will lead to affordable housing
 - Triplex and duplex construction (new construction)
 - Adding more hillside houses = increasing fire risk. Common sense would prevent this from happening but
 - Bear Valley, Abbott, Glen Alps, Rabbit have all filed resolutions opposing the HOMES initiative (Wondering if Hillside HCC has written something)
 - Rachel Ries did write against HOMES
 - Q 2 ordinances
 - 1 for June 25
 - Other is to be voted on June 11 Tuesday
 - A All things 2045
 - Encouraged people to show in person
 - 45 cuts community councils and platting out of the picture. We would have no voice
 - 45 is solely to "change the rules"
 - Many comments have been submitted
 - Christine lives on Jerome / Klatt.
 - A unit has been purchased; putting in accessory dwelling units; PNZ approved; breaking ground in mid-May
 - There was no active case listed in Huffman / O'Malley CC; not listed on any city portal; city official said they went thru PNZ and have the property permits
 - Putting up a 2800 foot shop and garage
 - Cut all trees down to the propertyline

- Asked city office why CC weren't notified; official said "we don't do that"
- Marc June suggests Christine contact the Ombudsman office
- PNZ vote on HOMES
