AO 2022-60 referendum 8/4/22 Development. The Assembly designated ARPA Funding, including the following: Park & Rec received \$1.2 to address beetle kill trees in municipal parklands; \$770,000 to south Potter March visitor site. AO 2022-75 property tax relief increased from \$50K to \$75K. AR 2022-208, 2022-221 grant to United Way (rental unit rehab) \$2.5M, AR 2022-22 purchase of Guest House \$2.2M. Suzanne LaFrance, District 6.

Kurt Parkan, aide, was present to answer questions but had no report to give.

HUD funding Revive in part (proposed) moving donated barracks from JBER. Proposed Municipality funding of \$1.6M fell through. Concern(s): quality of JBER housing donation?

 - D. Hillside no June meeting. Twice in July special meeting for traffic report (O'malley and rockridge). Draft response to Municipality in final edits in response to minu assessment. Shortage of 75 bus drivers for ASD. Requesting reconsideration for

pedestrian improvements re: O'Malley Elementary. Chief Schroge (sp?) (AFD) main guest for July meeting - open format meeting. Community feedback on Anchorage woodlot fees. Reviewing next year with no fees on the woodlot. Proactive concerns for pedestrian safety.

- E. Huffman/O'Malley On Summer break, no meetings. Significant increase in building at Abbot/O'Rabbit-Holy Transfiguration area causing resident concern. No official concerns/complaints currently.
