Re: Essential but Forgotten Campaign

To All Employees, People in Services, Guardians & Families,

Ability Resource Association has provided essential services for people with disabilities in Lethbridge since 1953. The disability services provided by our organization are funded in part by the Alberta Government, with the most significant portion being through Alberta Persons with Developmental Disabilities (PDD). The Alberta government has not provided increased funding to service providers for operations or to raise staff wages since 2014.

Individuals who receive PDD funded supports rely on these essential services and require stable, qualified staff to support them in their lives. Staff providing these essential and valuable services require skills, training, education and experience and deserve to be fairly paid for this important work.

As a charitable non-profit organization, we have always worked collaboratively and cooperatively with other service providers in our city, region and province. Our organization is a member of ADWA (Alberta Disability Workers Association) and ACDS (Alberta Council of Disability Services). ADWA has released the *'Essential but Forgotten'* campaign (www.adwa.ca) and we strongly support this campaign advocating for the Alberta Government to provide organizations supporting people with disabilities with the critically necessary funding increase necessary to allow organizations, such as ours, to raise the wages of the Community Disability Service Workforce. Having received no funded wage increases in 8 years, during a period in which inflation alone has increased by 14%, the Community Disability Service Workforce is significantly under paid. Combined with a highly competitive job market in the Lethbridge area, it is becoming increasingly difficult for organizations to attract and retain skilled workers.

The Management and Board of Directors of Ability Resource Association ask that our employees, people in services, their guardians and families write your MLA to bring attention to this issue and the *Essential but Forgotten* campaign.
