However, it would appear that the first length of overgrown hedging on the northern side of North End Road is in the Highway verge which is ECC Highways responsibility to cut back

Playing Field – Cllr A. Cooper

On 8<sup>th</sup>. December last, James and Cllr D. Smith met with John Butcher & Mark Prior from Gestingthorpe Cricket Club and we were also joined by a representative from Sudbury Cricket Club. The "subletting" to Sudbury Cricket Club would appear to have been ongoing for a number of years and is on a very informal basis. Cllr D. Smith is not quite certain whether Gestingthorpe CC receives a payment, or works to the cricket square in lieu, although a figure equating to about £65 per game was mentioned.

We raised the question of insurance and whilst it appears that Sudbury may have cover, Mark Prior advised that Gestingthorpe CC only have cover during the cricket season and this does not cover their equipment. The cricket nets, side screen and sheds, which I assume are the property of Gestingthorpe CC do not appear to be insured and there are potential Public Liability issues that need to be addressed. I suggest we need to refer this back to our Insurers for their guidance.

It was also clearly apparent from the comments made that the Gestingthorpe CC is struggling financially and with membership and needs all the help and support it can get. Both James and I confirmed the Parish Councils support for the club, although we both advised that Parish Councils approval is needed for any "sublet" arrangements they make with Sudbury CC or any other Cricket Club. It is clearly apparent that the current situation has evolved over a number of years and, bearing in mind the litigious world we live in, needs to be regularised.

John Butcher also raised the question of a seat in memory of the late Arthur Nears. I am mindful that the existing seats around the Pavilion and the seat that Gestingthorpe CC erected in memory of the late Phil Scillitoe, are not being maintained and there are also insurance issues that we need to consider.

The seat in memory of the late Phil Scillitoe, which replaced the recycled seat the Parish Council installed some years ago, is currently standing to the side of the Pavilion and is not in use. I suggest the recycled seat should be repositioned to the children's play area to replace the bench which has seen better days.

• Broadband update- Cllr S. Bolter & Cllr P. Collett

There was a power cut and when it came back a power surge knocked out the County Broadband 01376 562002 for information on 24hour status by pressing option 1

Following last month motion meeting Cllr S. Bolter contacted CBB and they are possibly looking at a second design
