Present: Cllrs J Nott (Chair), T. Flower (Vice-Chairman), S. Bolter, P Collett, D Smith, and Kevin B. Money (Parish Clerk). Also present was 10 members of the public

067/2019 Chairman Welcome. The Chairman welcomed everyone to the meeting

O68/2019 Apologies for Absence were received from ECC Cllr D. Finch, BDC Cllr W. Scattergood and Cllr A. Cooper

069/2019 To Co-opt onto the Parish Council

Cllr T. Flower proposed Claire Craig onto the Parish Council. This was seconded by Cllr S. Bolter. **All Agreed.**

Claire Craig then signed the Register of Interest, Declaration of Acceptance of Office and E Consent forms. She then took her seat as a Parish Councillor.

Cllr J. Nott proposed and Cllr D. Smith seconded that the minutes are a true and accurate record of the meeting. **All Agreed**

072/2019 To receive a presentation from James Salmon County Broadband. Max 15 minutes

James Salmon informed the meeting of the Current Actions since their last meeting in July were:-

- August First submission to Highways Agency for Traffic Management
- September Highways rejected proposed diversion routes as a result of the required road closure on Church Street
- October New Traffic Management proposal submitted to Highways after liaising with Bus company, School bus company and Local authorities regarding bin days etc. (12-week lead time)
- They are now awaiting confirmation of agreed dates, but these will not be until January due to shut down of Highways Agency over Christmas and also restrictions in build up to Christmas as they cannot restrict traffic flow during this period
- Plan is to now start the Build in late January with a completion target of March (subject to gaining Highways approval)
- They will look to accelerate this where they can, but majority of the build is under Road Closures which they cannot control
- When they have approval from Highways, they will host a launch event in the village hall and
 advertise it across the village so everyone can see how and where they are building to (this is
 likely to be in the New Year)
- They are in no way blaming Highways for the delay. It is very important that they maintain a strong, healthy and cooperative relationship with Highways

James Salmon then took questions from Councillors and residents

Cllr S. Bolter proposed that:-

The Parish Council calls upon County Broadband to fulfil its promise made in writing to residents of the New Cottages/The Crescent/Pot Kiln Chase area, and confirmed at the meeting County Broadband meeting in Gestingthorpe Village Hall on 2nd July 2019, that the Fibre to the Premises broadband in that area would be underground.

Cllr P. Collett seconded the motion. F 4 - Ag 0 - Ab1. The motion was carried.

073/2019 Public Participation Session

The Chairman will invite questions and observations from members of the public present. John Butcher informed Councillors that:-

- 1. The cricket facilities being used 5 or 6 times a year by Sudbury Cricket Club with whom we have a friendly relationship. (Our field captain is Kenny Moulton and he plays for the Sudbury first team *and* Suffolk and our kids are looked after by Sudbury while we train two of our members to become youth coaches). The match fees will pay for the cricket pitch repair and maintenance.
- 2. The proposed extension: the provision of a new changing room at the far end and general improvements. (The grant application result will be decided on the 15th November).
- 3. Insulating the pipework so the footballers can use the facilities in the winter. I think one of our members will do this anyway if the weather gets colder.
- 4. The cricket club erecting a bench in honour of Arthur Nears.

After a lengthy discussion it was decided that more clarity was still needed on points 1, 2 and 4 Meeting of Parish Councillors (David Smith), Landlord, Sudbury CC and Gestingthorpe CC was agreed.

Cllr J. Nott proposed that the Cricket Club be successful and there is more clarity. Cllr S. Bolter seconded. All Agreed

Cllr J. Nott requested a plan be submitted to the Parish Council of the benches at the cricket ground.
