#### 105/2023 Representative reports

• Highways – Cllr P. Collett

**SID Sudbury Road** - The speed survey has now been carried out by ECC and the results are awaited. **Potholes** - I have reported a number of potholes and damaged road signs on the ECC Highways website. **Speeding** - Speeding persists within the village at dangerous levels. The Rural Policing Unit carried out a speed watch on Sudbury Road on 11<sup>th</sup>. September. I will continue to liaise with Sergeant Ben Felton to establish if this can be a more regular occurrence. I met with two PCSO's at last week's coffee morning and asked if they could assist in providing some further speed watches. They seem keen to help and I have followed up our conversation with an email outlining the problem of speeding within the village and requesting further help. I have been approached by Ms Helen Skerratt who is very concerned about the speeding on Northend Road and the danger that it is causing. Helen is requesting the Parish Council's help in trying to establish a 30mph limit. Road signage has been broken and reported to ECC.

**F315 Bus Service** - The Parish Council have responded to the Consultation regarding the future of the service with a strong recommendation that the service is retained. The Parish Councils response was coordinated with neighbouring Parish Councils and in addition the Parish Council lobbied County Councillors and our District Councillor for their support

Play Equipment No further items to report

Playing Field – Cllr A. Cooper

I walked around the Playing Field on Monday evening. The previous concerns re. overhanging branches remain. The winter would be a good time to plant one or two saplings along the Sudbury Roadside, so that there are young trees growing there, when less healthy trees eventually die. Could they be Queen Elizabeth or King Charles memorial trees? Someone has cut out the ditch near the Children's Play Equipment. We hope to cut the remainder of the hedge, on a similar basis to previous years, but need to finish autumn drilling first, so that the tractor is free. (It takes several hours to put the hedge cutter on.) The bigger gutters and down pipes which have been installed on the pavilion are a really excellent improvement and make clearing out so much easier. They were done this morning. A small modification could be considered for the bottom of the down pipes. The mowers are being kept at the back of the pavilion. The pitch is bearing up very well, despite the wet weather. Football has resumed again. Special thanks should be made to Peter Nice for marking the pitch out

The Bluff my Cheese fundraiser held on 20<sup>th</sup>. October was a great success despite low attendance and several last-minute cancellations caused by the poor weather. The event made a net profit of £471.44. Current planning is for the Village Christmas Fun day and Craft Fayre on 18<sup>th</sup>. November. This event will include local crafters selling their own made items a cake stall, Children's crafts, face painting, competitions & raffle, sausage sizzle and the Belchamp Singers. On the day we will also be launching our Village Hall recipe book which contains cakes recipes provided by our coffee morning bakers. The Children's & Adults Christmas parties will be held on the 9<sup>th</sup>. & 15<sup>th</sup>. December. Hall Hire has improved with several private hires booked for November & December. As at the last committee meeting on 12<sup>th</sup>. October, the VH held a total of £5,453.64 in cash and in the bank account. The next committee meeting is on 23<sup>rd</sup>. November 2023.
