FRIDAY TWO WEEKS PRIOR TO THE BEGINNING OF THE OFFICIAL PRACTICE DAY. ENTRIES RECEIVED AFTER THIS TIME WILL BE SUBJECT TO A \$25.00 LATE FEE AND MUST BE PAID IN CASH.**

The Tournament waters shall be off limits to all competitors commencing at 12:01a.m, **MONDAY THE WEEK OF THE TOURNAMENT**, until safe light on the first practice day.

**Off Limits Area;** Spillway Bay will be the live release area and the only off limits area for the tournament. **Markers will be placed at the mouth of the bay indicating the beginning of the off limits area.**

DURING THE OFFICIAL PRACTICE AND COMPETITION DAYS OF COLORADO T.B.F. Inc. TOURNAMENT, NO CONTESTANT MAY OPERATE A BOAT UNLESS THAT CONTESTANT HAS A MINIMUM OF \$300,000 BOATING LIABILITY INSURANCE. THIS DOCUMENTED PROOF MUST SHOW AN EFFECTIVE DATE AND EXPIRATION DATE AND MUST BE MAINTAINED IN THE COMPETITORS BOAT. THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRE-TOURNAMENT PRACTICE OR THE TOURNAMENT.
