Treasurer's Report: Presented and approved.

Marybeth Crabtree advised that her efforts to obtain more favorable interest rates did not provide any advantages to change from away from Sovereign Bank.  
Mr. Blaisdell offered to research into other local banks and report back to the Board.

Golf, Tennis, and Beach ...Nothing to report so early in the season

The Board agreed to ask Scott Nickerson to submit his Golf Maintenance Report every two weeks, instead of once a month.

The Board spent considerable time reviewing a draft letter prepared to be sent to the President of NSMGA (Mike Alberico). In accordance with the Board's meeting of November 8 2012, Mr. Stenberg provided a draft document that asked if the NSMGA could address several of our members concerns and directions, including accountability and transparency of the 2012 season. A detailed discussion followed: some members of the Board did not believe that NSMGA was a Board issue, while others felt that, due to this continuing topic coming up over several meetings, some action was proper. Mr. Richardson proposed that the Board should prepare a letter to be sent by the BOM to Club Management. The letter would address the need for better communication between Club Management and the NS Men's Golf Association. The Board unanimously voted to generate a letter to be sent to Steve Brennan Club Manager.
