36 § 241 Conspiracy Against Rights

37 If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any
38 State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of

1 **any right or privilege secured to him by the Constitution or laws of the United States, or**
2 **because of his having so exercised the same; or**

3 If two or more persons go in disguise on the highway, or on the premises of another, with
4 intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured—
5 They shall be fined under this title or imprisoned not more than ten years, or both; and if death
6 results from the acts committed in violation of this section or if such acts include kidnapping or
7 an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual
8 abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of
9 years or for life, or both, or may be sentenced to death.

16 **§ 285 Taking Or Using Papers Relating To Claims**

17 **Whoever, without authority, takes and carries away from the place where it was filed,**
18 **deposited, or kept by authority of the United States, any certificate, affidavit, deposition,**
19 **statement of facts, power of attorney, receipt, voucher, assignment, or other document,**
20 **record, file, or paper prepared, fitted, or intended to be used or presented to procure the**
21 **payment of money from or by the United States or any officer, employee, or agent thereof, or**
22 **the allowance or payment of the whole or any part of any claim, account, or demand against**
23 **the United States, whether the same has or has not already been so used or presented, and**
24 **whether such claim, account, or demand, or any part thereof has or has not already been**
25 **allowed or paid; or**

26 **Whoever presents, uses, or attempts to use any such document, record, file, or paper so taken**
27 **and carried away, to procure the payment of any money from or by the United States, or any**
28 **officer, employee, or agent thereof, or the allowance or payment of the whole or any part of**
29 **any claim, account, or demand against the United States—**

30 **Shall be fined under this title or imprisoned not more than five years, or both.**

32 **§ 286 Conspiracy To Defraud The Government With Respect To Claims**

33 **Whoever enters into any agreement, combination, or conspiracy to defraud the United States,**
34 **or any department or agency thereof, by obtaining or aiding to obtain the payment or**
35 **allowance of any false, fictitious or fraudulent claim, shall be fined under this title or**
36 **imprisoned not more than ten years, or both.**

§ 872 Extortion By Officers Or Employees Of The United States

Whoever, being an officer, or employee of the United States or any department or agency thereof, or representing himself to be or assuming to act as such, under color or pretense of office or employment commits or attempts an act of extortion, shall be fined under this title or imprisoned not more than three years, or both; but if the amount so extorted or demanded does not exceed \$1,000, he shall be fined under this title or imprisoned not more than one year, or both.

§ 875 Interstate Communications

(d) Whoever, with intent to extort from any person, firm, association, or corporation, any money or other thing of value, transmits in interstate or foreign commerce any communication containing any threat to injure the property or reputation of the addressee or of another or the reputation of a deceased person or any threat to accuse the addressee or any other person of a crime, shall be fined under this title or imprisoned not more than two years, or both.

In regards subparagraph 2 of paragraph 1 your nonsense letter " THIS IS YOUR NOTICE OF DEFICIENCY" as required by law:

§ 6212 Notice Of Deficiency

(a) In general

1 If the Secretary (ARE YOU THE SECRETARY?) determines that there is a deficiency in respect of
2 any tax imposed by subtitles A HOWEVER THERE ARE NO LIABILITY STATUTES IN SUBTITLE A
3 FOR INDIVIDUALS THUS SUBTITLE A IS A VOLUNTARY TAX or B (SINCE YOU NEVER GIVE
4 SPECIFICS ON WHAT SECTION OF THE TITLE IMPOSES YOUR ALLEGED TAXES BUT ONLY
5 MENTION PORTIONS OF SECTIONS 6601 AND UP ANYONE CAN PRESUME THAT SUBTITLES A OR
6 B DON'T APPLY HERE) or chapter 41PUBLIC CHARITIES, 42 PRIVATE FOUNDATIONS; AND
7 CERTAIN OTHER TAX EXEMPT ORGANIZATIONS, 43QUALIFIED PENSIONS, ETC., PALNS, or
8 44QUALIFIED INVESTMENT ENTITIES he is authorized to send notice of such deficiency to the
9 taxpayer by certified mail or registered mail. Such notice shall include a notice to the taxpayer
10 of the taxpayer's right to contact a local office of the taxpayer advocate and the location and
11 phone number of the appropriate office. SO, CHRISTINE*** WHAT IS OR ARE THE TAXABLE

16 (b) Address for notice of deficiency

17 (1) Income and gift taxes and certain excise taxes

18 In the absence of notice to the Secretary under section 6903 of the existence of a fiduciary
19 relationship, notice of a deficiency in respect of a tax imposed by subtitle A, chapter 12, chapter
20 41, chapter 42, chapter 43, or chapter 44 if mailed to the taxpayer at his last known address,
21 shall be sufficient for purposes of subtitle A, chapter 12 APPLICABLE ONLY TO GIFT TAXES,
22 chapter 41, chapter 42, chapter 43, chapter 44, and this chapter even if such taxpayer is
23 deceased, or is under a legal disability, or, in the case of a corporation, has terminated its
24 existence.
