The Bennet City Council (the "Council") of the City of Bennet, Nebraska (the "City") held a regular business meeting on Monday June 12, 2023 at 7:00 p.m., at the Bennet City Hall, 685 Monroe Street in the City, the same being open to the public and preceded by advance publicized notice duly given in strict compliance with the provisions of the Open Meetings Act, Chapter 84, Article 14, Reissue Revised Statures of Nebraska, as amended, and having set forth (a) the time, date and place of the meeting: (b) that the meeting would be open to the attendance of the public; and (c) that the agenda for the meeting, kept continuously current, was available for public inspection at the office of the City Clerk and posted at the City Office, Post Office and First Nebraska Bank.

Mayor Ryan Cheney called the meeting to order at 7:00 p.m. and announced the location of the Open Meetings Act. City Clerk Michele Lincoln conducted roll call. Council Members in attendance were Pete Simmons, Dan Zieg, Steve Bettendorf, Justin Dorn and Mayor Ryan Cheney. A quorum being present, and the meeting duly commenced, the following proceedings were taken while the meeting remained open to attendance by the public. The Pledge of Allegiance was recited.

Simmons moved and Bettendorf seconded a motion that all items under the consent agenda be approved and accepted as presented. Roll call vote: Simmons, Zieg, Bettendorf, Dorn voted YES. Motion carried.

Nicole Kobus with SparqData gave a presentation on the Sparq Meeting Program. The Sparq Meeting Program is a cloud-based program that interfaces agenda's, meeting materials, and minutes.

Cameron Jensen submitted an agenda request that the City provide cardboard recycling at the refuse site. Jensen was not in attendance. The Council discussed the cost and logistics of monitoring it for compliance. No action was taken.

The Mayor suggested and the Council agreed to address the discussion of Celebrate Bennet 4th of July Celebration prior to the following agenda items. Kirsten and Eric McMann were in attendance to represent the Celebrate Bennet 4th of July Committee. Kirsten reported that it will be a scaled down version this year. They will have the cake walk, flag retirement, concessions, and fireworks on the 3rd. The 4th will have the same street closures, the fun run, breakfast at the Fire Station, parade, BMX show, food trucks and firehose. Tailored Life 360 is tentatively hosting the craft fair on their patio. There will be no kids rides this year. The Committee did not solicit funds this year and there should be some funds

remaining to turn them over to the new group sponsoring the event next year. The Council questioned how many volunteers were needed the day of the event. Kirsten replied 6-8 people were needed for the parade, 6 people parking cars for the fireworks and people to cleanup. If the pedal pull was brought back 6 people would be needed for that and stated that bringing in the food trucks is a lot less work.

Mayor Cheney introduced Ordinance 2023-6.1, AN ORDINANCE OF THE CITY OF BENNET, LANCASTER COUNTY, NEBRASKA, TO VACATE THE NORTH-SOUTH ALLEY AND EAST-WEST ALLEY IN BLOCK 1, WEST BENNET ADDITION TO THE CITY OF BENNET, LANCASTER COUNTY, NEBRASKA, WITH TITLE REVERTING TO THE ABUTTING PROPERTY OWNERS; TO MAKE FINDINGS; TO RESERVE RIGHTS; AND TO PROVIDE FOR PUBLICATION AND AN EFFECTIVE DATE. Zieg moved and Bettendorf seconded a motion to waive the three-reading rule for ordinance 2023-6.1. Roll call vote: Simmons, Zieg, Bettendorf, Dorn voted YES. Motion carried. Zieg moved and Dorn seconded a motion to approve Ordinance 2023-6.1. Roll call vote: Simmons, Zieg, Bettendorf, Dorn voted YES. Motion carried.

Mayor Cheney introduced Ordinance 2023-6.2, AN ORDINANCE OF THE CITY OF BENNET, LANCASTER COUNTY, NEBRASKA, TO AMEND SECTION 150.002 OF THE CITY CODE TO CHANGE THE COMPOSITION OF THE BOARD OF APPEALS; TO REPEAL CONFLICTING ORDINANCES; AND TO PROVIDE FOR PUBLICATION AND AN EFFECTIVE DATE. Dorn moved and Zieg seconded a motion to waive the three-reading rule for ordinance 2023-6.2. Roll call vote: Simmons, Zieg, Bettendorf, Dorn voted YES. Motion carried. Dorn moved and Bettendorf, Dorn voted YES. Motion carried.

A pre-recorded presentation of the TextMyGov program was played for the Mayor and Council. TextMyGov is a program that assists citizens with requests 24/7 by texting key words that direct them to the proper resources and allows the City to send notice to citizens.
