Rotary International in Great Britain and Ireland (RIBI) promise to respect the confidentiality of any personal data you share with us, or that we have access to through Rotary International (RI), to keep it safe, and we will always take every effort to protect your privacy. We pride ourselves on our honesty and openness and will always be clear how, when and why we collect and process your information; we promise we will never do anything with your details that you wouldn't reasonably expect to allow us to manage your membership and provide the services you are entitled to. It is expected that club and district officers may also process member personal data on behalf of RIBI and RI and they too will also be bound by the RIBI privacy notice.
