Sea2Stable INC shall have complete and sole discretion in the approval or denial of any adoption application. This may be for any reason, including but not limited to concerns over the potential adopter's ability to provide a safe environment for the Equine.

Any potential adopter will need to work with the Equine at the Sea2Stable facility twice before adoption will be finalized. If approved for adoption, a Sea2Stable representative will visit the adopter's facility one week and 30 days post adoption to offer guidance at no charge. Sea2Stable has a strict no breeding policy. Any Equine available for adoption at Sea2Stable shall have a veterinary exam prior to adoption at Sea2Stable's expense, and all veterinary records will be made available to the adopter.

If Sea2Stable determines that the adoption will not be successful, or the adopter desires to return the horse, the adopter will receive a 50 percent refund of the adoption fee for a return up to 30 days post adoption. For a return between 30 and 60 days post adoption, the adopter will receive a 25 percent refund of the adoption fee. After 60 days, the adopter will not receive a refund, but the horse will be returned directly to Sea2Stable. If the adopter desires to sell the horse one year after adoption, they must notify Sea2Stable before listing the horse for sale.
