Dues are pro-rated for the first year of membership to pay in full through December.

Annual dues are due and payable on January 1st each year. Dues left unpaid after the March General Club meeting are considered delinquent and the membership will be dropped. Initiation fees will be required to re-join the club. It is the responsibility of each member to pay dues when due whether or not a reminder and/or statement is received.
