The President of the Council remains an ex-officio member of all Committees. The Council President shall have a reasonable expectation of being informed of committee activities, specifically when meetings will occur and the agenda of those meetings.

All Committee meetings shall be publicly advertised per the Sunshine Act. Minutes that offer summaries of discussions and activities shall be drafted by the Borough Staff or a member of the Committee. All minutes shall be made available to the Borough Council and the Public. The Personnel Committee is granted authority to enter an Executive Session on Personnel Matters or matters related to Collective Bargaining. The committee must advise the Borough Council that those meetings took place and announce those meetings publicly at the next scheduled Council meeting.

The staff liaison to all committees shall be the Borough Manager per Ordinance No. 890; the Borough Manager remains the day-to-day manager of operations. Membership of any committee does not empower members of the Council to contact staff members or professionals and commission work individually. All requests from individual Council Members must be directed to the Borough Manager. The Borough Manager may refer those requests directly to staff members, including asking individual council members to call them directly about the discussed matter for follow-up and completion.
