ORDINANCE NO: 901

**AN ORDINANCE OF THE BOROUGH OF MOUNT PENN, BERKS COUNTY, PENNSYLVANIA,
FIXING THE TAX RATE FOR THE FISCAL YEAR 2025.**

Be it ENACTED and ORDAINED by the Borough Council of the Borough of Mount Penn, Berks County, Pennsylvania and it is hereby ENACTED and ORDAINED by the authority of the same as follows:

SECTION 1. A tax and the same is hereby levied on all real property within the Borough of Mount Penn, Subject to taxation for Borough Purposes for the fiscal year 2025 at 16.10 Mills as follows:

- A. The tax rate for General purposes is the sum of 13.45 mills on each dollar of assessed valuation.
- B. The tax rate for Fire/Emergency purposes is the sum of 1.75 mills on each dollar of assessed valuation.
- C. The tax rate for Emergency Medical Services/Ambulance purposes is the sum of 0.50 mills on each dollar of assessed valuation.
- D. The tax rate for Street Light purposes is the sum of 0.40 mills on each dollar of assessed valuation.
- E. The value in dollars is \$1.610 for every \$100.00 assessed property value.

SECTION 2. Any Ordinance or parts of Ordinances inconsistent herewith shall be the same and are hereby repealed.
