  - 2. There should be a vote relative to that and somebody needs to do the plans. Chris could probably draw something up for you. And that should be submitted to the authority and they have to approve it. So once once those two things have occurred, and St. Lawrence borough if they are going in on this with us, they need to take action on it and then once everyone's in agreement, then the streets people need to let us know what the agreement is between the two municipalities. Relative to this building. We don't the all of that needs to be done before we start breaking ground.
  - 3. If the authority approves the borough, putting a building there, the agreements between if I understand you correctly, this building is not an authority building it will be a Borough and a another large St. Lawrence building. So we would be building it on authority land, I'm assuming the authority would probably I'm hopeful that they would grant us a long term lease of that ground so that we could do that. But there's a lot that has to occur. So look for any of any of this other stuff happens. I mean, having the money in advance, I mean, that's great, but we got a lot of other things that have to happen.
