## ordinance no. 731

AN ORDINANCE OF THE BOROUGH OF MOUNT PENN, BERKS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 687, PART 4, RESCINDING LOADING ZONE PARKING, 15 MINUTE PARKING AND NO PARKING BUSINESS LOADING ZONE IN THE 2300 BLOCK OF PERKIOMEN AVENUE AND RESCINDING 15 MINUTE PARKING AND A NO PARKING AREA ON THE EAST SIDE OF NORTH  $24^{\text{TH}}$  STREET.

- BE IT ENACTED AND ORDAINED by the Council of the Borough of Mount Penn, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by authority of the same, as follows:
- SECTION 1. Loading zone parking Thursday, Friday and Saturday, between the hours of 12:00 noon until 8:00 p.m., starting 290 feet from the northwest corner of Perkiomen Avenue and North 24th Street, continuing for a distance of 20 feet in an easterly direction along the north side of Perkiomen Avenue, shall be rescinded.
- SECTION 2. Fifteen minute parking starting 195 feet from the northwest corner of Perkiomen Avenue and North  $24^{\rm th}$  Street, continuing for a distance of 20 feet in an easterly direction along the north side of Perkiomen Avenue, shall be rescinded.
- SECTION 3. No parking, business loading zone, starting 72 feet from the northwest corner of Perkiomen Avenue and North  $24^{\rm th}$  Street, continuing for a distance of 72 feet in an easterly direction along the north side of Perkiomen Avenue, shall be rescinded.
- SECTION 4. Fifteen minute parking from 8:00 a.m. to 6:00 p.m., starting 46 feet from the northeast corner of Perkiomen Avenue and North  $24^{\rm th}$  Street, continuing for a distance of 20feet in an southerly direction along the east side of north  $24^{\rm th}$  Street, shall be rescinded.
- SECTION 5. No parking starting 26 feet from the northeast corner of Perkiomen Avenue and north  $24^{\rm th}$  Street, continuing for a distance of 26 feet in a southerly direction along the east side of north  $24^{\rm th}$  Street, shall be rescinded.
- SECTION 6. Any Ordinance or parts of Ordinances inconsistent herewith shall be and the same are hereby repealed.
