ORDINANCE NO. <u>757</u>

AN ORDINANCE OF THE BOROUGH OF MOUNT PENN, BERKS COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 687, PART 2, ESTABLISHING MAXIMUM SPEED LIMITS, MONDAY THROUGH FRIDAY, BETWEEN THE HOURS OF 8:00 A.M. UNTIL 9:00 A.M. AND 2:45 P.M. THROUGH 3:30 P.M. IN CERTAIN SCHOOL AREAS, AND AMENDING ORDINANCE NO. 687, PART 4, RESTRICTING PARKING AT THE MOUNT PENN PRIMARY CENTER, MONDAY THROUGH FRIDAY, BETWEEN THE HOURS OF 8:00 A.M. UNTIL 9:00 A.M. AND 2:45 P.M. THROUGH 3:30 P.M.

BE IT ENACTED AND ORDAINED by the Council of the Borough of Mount Penn, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by authority of the same, as follows:

- SECTION 1. Maximum speed limits of 15 miles per hour between the hours of 8:00 a.m. until 9:00 a.m. and 2:45 p.m. until 3:30 p.m., Monday through Friday, shall be established as follows:
- A. North 25th Street starting 150 feet south of Filbert Avenue and continuing for a distance of 344 feet north of Filbert Avenue;
- B. Filbert Avenue commencing 158 feet west of North 25th Street and continuing east to Endlich Avenue; and
 - C. Endlich Avenue from Glen Terrace to Philmay Terrace.
- SECTION 2. Parking shall be restricted for the Mount Penn Primary Center, Monday through Friday, between the hours of 8:00 a.m. until 9:00 a.m. and 2:45 p.m. until 3:30 p.m., along the east side of North 25th Street, beginning at the intersection of Filbert Avenue and North 25th Street and continuing 158 feet north.
- SECTION 3. Any Ordinance or parts of Ordinances inconsistent herewith shall be and the same are hereby repealed.
