A RESOLUTION OF THE BOROUGH COUNCIL OF MOUNT PENN, BERKS COUNTY,
ADOPTING A BUDGET FOR THE AMBULANCE FUND

**WHEREAS**, Sub-Section 1307 of the Borough Code requires that the Council of Mount Penn Borough adopt a budget on or before December 31<sup>st</sup> each year; and,

**WHEREAS**, the Borough of Mount Penn has duly advertised a public notice for inspection of the proposed 2025 Budget for all funds as required by Sub-Section 1308 of the Borough Code; and,

**WHEREAS**, the Borough of Mount Penn wishes to set certain goals that will be pursued by the Borough in 2025.

**NOW, THEREFORE, BE IT RESOLVED,** that the Members of the Borough Council of Mount Penn Borough hereby adopt the 2025 Budget for each fund herein as follows:

#### Section 1 - Ambulance Fund

The Ambulance Fund will be adopted with \$46,048.99 in Revenue and \$45,048.99 in Expenditures.

#### Section 2 - Delegation of Responsibility

The Borough Manager is authorized to make or receive payments based on the approved revenues and appropriations herein.
