MEETING OF THE MOUNT PENN BOROUGH COUNCIL November 30, 2021

The Mount Penn Borough Council met in regular session on November 30, 2021 President Goodman brought the meeting to order at 7:30 P.M. and led the Pledge of Allegiance. Responding to roll call were, President Troy Goodman and Council Members John Fielding, Rick Lombardo, Ryan Maurer, Tom Staron, James Cocuzza and Roger Reto. Also in attendance were Assistant Secretary Rochelle Gresh, Chief Serafin, Mayor Josh Nowotarski, Engineer Chris Falencki, and Solicitor Zach Morey.

Engineer Chris Falencki left at 9:01 PM.

I. AUDIENCE PARTICIPATION:

Santiago Serrano from State Representative Chrissy Houlahan spoke about the services they provide for the Borough and the residents.

Kyla Ramsey from 2449 Fairview inquired about the zoning hearing and an update on the alley, shed and other issues on 2451 Fairview Street and mentioned how she wasn't properly notified of the hearing.

Paul Janssen discussed the budget and how we will not have to raise taxes. A discussion was made on getting a loan for the current projects and a short-term loan for another capital project. A motion was made by Mr. Lombardo to look into getting a loan with our bank. Seconded by Mr. Cocuzza. The motion carried unanimously.

II. EXECUTIVE

Executive Session was held from 8:08 to 8:19PM and personnel issues were discussed.

Motion made by Mr. Fielding to raise Rochelle's rate to \$28.00 an hour effective January 1, 2022 and authorize benefits for her effective January 1, 2022 to an increase to 35 hours per week. Seconded by Mr. Lombardo. The motion carried unanimously.

A motion was made by Mr. Fielding to authorize solicitor's office to develop and ordinance to create the position of borough manager and advertise it accordingly. Seconded by Lombardo. The motion carried unanimously.

A motion was made by Mr. Fielding to advertise for the budget 2022 and advertise an ordinance for your taxation rates to remain the same as last year. Seconded by Cocuzza. The motion carried unanimously.
