




#### **STCC ALL ABOUT POINTS**



It's that time of year when STCC is happy to be able to make its annual donations to the local charities we support. The first in the series of donations is the KDKA Annual Turkey Fund. The KDKA-TV Turkey Fund is a partnership between PNC Bank and the Greater Pittsburgh Community Food Bank. The KDKA-TV Turkey Fund has provided Thanksgiving dinners for our neighbors in need for over 40 years!

What makes our donation even more valuable is the fact that any donation of \$50 or more made will be matched by PNC up to \$75,000. #### These Are the Only Road Legal Headlight Colors in the US

For all the color choices available to car buyers, your headlights remain painfully simple. White and yellow. Yes, that's it. Can't use the colors on the rainbow except for yellow. Every glowing beam on an American road is beholden to the same two hues, and that's no accident. According to Federal Motor Vehicle Safety Standard (FMVSS) No. 108, regulated by the National Highway Traffic Safety Administration, headlights must emit white or "selective yellow" light for safety and standardization.

The idea is as old as the automobile: Consistency saves lives. Early 1880s motorists used the very first headlights, before the light bulb was invented. They were acetylene (carbide) lamps that glowed yellow and weren't safe — they could leak and explode. In 1898, the first electric headlamp was used in the Electric Vehicle Company's Columbia, a pioneering battery-powered vehicle.

Then came the evolution to halogen lamps, xenon or High-Intensity Discharge lights, and the modern Light Emitting Diode (LED) lights. Amber-colored lights were standardized for signals and hazard markers since their warm tone stands out from white, improving reaction time in poor conditions.

So, while modern cars can practically drive themselves, the light ahead of you is still bound by the logic of clarity and tradition. Because when you're moving at speed, the last thing you need is a light show.

#### The trouble with color: Modding, enforcement, and what's not allowed

Penalties vary, but most states can issue fix-it tickets, inspection failures, or fines for illegal headlight colors. For instance, in Tennessee, it's a Class C misdemeanor to violate the white-or-yellow color requirement. And in 2018, a \$50 penalty was imposed there for not keeping headlights a standard color.

Of course, there's always someone who thinks "rules" are just mild suggestions especially in the world of car mods. Enter the enthusiasts fitting RGB halos, demon eyes, and tinted daytime running lights. These are the same people who think underglow lights are lit and legit (often they're not). As long as they have white or yellow headlights per FMVSS 108, there will be no problem at all.

Colors like blue, red, and green are explicitly banned because they mimic police and emergency lights, which can lead to confusion or a citation that hurts worse than a burned-out ballast. Even white LEDs that give a hint of the blue spectrum have come under scrutiny. Well, they're not really blue; it's the color temperature (which runs about 5,000 to 6,500 Kelvin, or 8,540 to 11,240 Fahrenheit) that gives them a blue appearance.

When it comes to headlights, even the wildest modder has to bow to the law. White or yellow for seeing. Amber for signaling. Everything else? Keep it for the car show. Because on public roads, light isn't just about looking cool. It's about making sure everyone survives.

#### Can You Use Windex on Car Windows?

Your car's windows and windshield are among its hardest parts to clean. Auto glass is clear, for starters, and using the wrong cleaning products could introduce streaking and affect driving visibility. The original Windex glass cleaner seems fine for cleaning exterior glass because it contains ammonia, a potent solvent that evaporates quickly, making it unlikely to leave streaks on the windows and windshield.

However, the fumes and strong odor could irritate the skin, eyes, throat, and respiratory system of vulnerable users. And since ammonia is a solvent, it can prematurely degrade window tints, causing them to fade, crack, or discolor with repeated exposure, making it unsuitable for cleaning interior auto glass. Moreover, glass cleaners with ammonia could be harmful and toxic when mixed with bleach. Doing so produces chloramine vapors, which can cause pulmonary edema, or fluid in the lungs, with prolonged exposure.

Windex is great for cleaning windows and other hard surfaces around the home, but we prefer ammonia-free glass cleaners when cleaning car windows and windshields. Windex's ammonia-free glass cleaner is more suitable for use in cars, and the mild formula can clean tinted windows without damaging them, though Windex recommends you "test in an inconspicuous spot first, since there are different qualities of tint." What's more, ammonia-free glass cleaners have no strong odors or fumes that could pose health risks or cause foggy windows. Windex also has a vinegar-based glass cleaner that makes do without ammonia, so it's another safer alternative to original Windex.

#### Tips and tricks for streak-free auto glass

Your car's windows and windshield are tricky to keep clean because you need to treat both the inside and outside. Exterior glass surfaces are consistently exposed to the elements and can accumulate dirt, fingerprints, streaks, and water spots. Interior glass, meanwhile, is prone to fogging and haze from air fresheners, smoking, or vaping. In short, you can't achieve clarity without cleaning both sides.

It's best to treat the windows with glass cleaner after washing the entire vehicle with soap and water to remove excess dirt and grime. Avoid using glass cleaners under direct sunlight or if the surface is hot to the touch, and this applies when cleaning both the outside and inside glass. Cleaning them when they're too warm might cause the cleaner to evaporate quickly and cause streaking.

Only pair glass cleaner with a clean, dedicated microfiber towel. Avoid using towels you use for wiping the car's body or interior on auto glass, since contaminants from the paint or dashboard will inevitably streak the windows and windshield. Furthermore, do not use sponges or harsh cloths that can scratch the glass and window tint. Mixing distilled water with a teaspoon or two of white vinegar in a spray bottle is an excellent alternative to Windex. It's potent enough to rid the inside windows of haze, mild enough for tinted windows, and is highly effective in keeping auto glass fog-free in hot or cold weather.



#### What It Means If a Gas Can Is Swollen or Collapsed!

A swollen or collapsed gas container gets that way because of the change in vapor pressure inside it. It looks dangerous, but it usually isn't.

A swollen or <u>collapsed gas container</u> can be an unsettling thing to discover in your garage, but it's a great learning opportunity. The container changes shape because of the changing vapor pressure of gasoline, which is highly volatile and readily evaporates. Scientists have known since the 17th century that the pressure a vapor exerts on the sides of a container changes with temperature, and they

formulated this insight into a mathematical relationship known as the Boyle-Mariotte Law (also known as the Ideal Gas Law). You may have heard about it in high school science classes.

According to this law, the product of pressure (P) and volume (V) of a gas is equal to the product of the amount of gas present (n), the ambient temperature (T) and a fixed number known as the universal gas constant (R). In mathematic terms, that's written as PV=nRT. Since a gas container has a fixed volume, the equation can be rearranged to read P=kT, where k is a constant (nR/V). This tells us that when temperature goes up, vapor pressure goes up, and vice versa.

If science and math aren't your specialty, you can take the word of HVAC pro Sergey Nikolin, who deals with vapor pressure as part of his job: "Gas cans swell and collapse due to temperature changes, as gasoline vapors expand when heated and contract when cooled."

Unfortunately, a swollen or collapsed gas can be potentially dangerous, given the flammability of gasoline, but you can avoid accidents by using the right container and following some simple guidelines. We'll tell you all about it.

#### Why Do Gas Cans Swell?

A gas container swells when the ambient temperature goes up, and if you've been paying attention, you already know why: It's because the vapor pressure in the container has also increased. The pressure inside the container was the same as atmospheric pressure when you filled it and closed the cap, but when the pressure inside the container increases and exceeds atmospheric pressure, it pushes the sides out. "It's completely normal for a sealed container, but honestly, it can be a little surprising if you're not used to it," says Chris Turner, a designer of luxury fire pits.

#### Is a swollen gas can dangerous?

It can be, warns Nikola— especially if you're using an old gas container. "Excessive swelling can weaken the can over time or even cause it to rupture if it's old or damaged. Over time, the flexing can cause invisible micro-cracks, potentially leading to undetected vapor leaks."

If your can conforms to Occupational Safety and Health Administration (OSHA) specifications, there's less danger of an accident than if it isn't. That's because OSHA-approved containers:

- Hold a maximum of five gallons;
- have a flame-arresting screen under the cap;
- have a spring-closing lid and spout cover;
- have a valve that safely relieves pressure when the container is exposed to fire.

Not all containers on the market are OSHA compliant, so if safety is a priority, choose one that bears the OSHA label.

#### How to open a swollen gas can

Slowly and carefully. Some of the vapor will escape, so to prevent inhaling it and/or creating a fire hazard, you should always be in a well-ventilated area—preferably outside. You should never be near an open source of heat because if the vapor ignites, it can flash back to the can and ignite the liquid gasoline. Such accidents are rare, but they do happen. NBC News reported 11 deaths and 1,200 emergency room visits between 1998 and 2013 because of this phenomenon.

On hot days, the sun can potentially provide enough heat for flashbacks, so you should always be in the shade. One more thing: Don't open the can while it's resting on a metal surface because metal generates static electricity that can produce sparks.

#### Should I use the gas in a swollen gas can?

If the container is still intact and the swelling is moderate, the gas should be safe to use. However, an old container and/or extreme swelling can cause small ruptures and possible contamination. If this occurs, it's a good idea to discard the fuel.

#### Why Do Gas Cans Collapse?

When the vapor pressure in a gas container decreases due to low ambient temperatures, it can't resist the force of atmospheric pressure pushing on the sides, and the container collapses.

#### Is a collapsed gas can dangerous?

A swollen or collapsed gas can is never a good thing if it is old. Old cans "don't always handle pressure changes well," says Turner. Cracks or leaks can develop, and that's where the fire hazard comes in."

If an old can collapses and ruptures, it won't release fumes while the temperature is low and the can is collapsed, but it very well might when the temperature rises, the vapor pressure increases and the can regains its normal shape and begins to swell. That's a time bomb you want to avoid.

#### How to fix a collapsed gas can

It may seem strange, but a gas can is supposed to collapse, at least as far as the Environmental Protection Agency (EPA) is concerned. Unlike OSHA, the EPA prohibits pressure-relief vents because they allow gas fumes to escape into the atmosphere. With no way to equalize vapor pressure inside and outside of it, the container has no choice but to collapse.

Restoring an EPA-approved can without a pressure-relief vent it to its normal shape is easy. Simply remove the lid to equalize pressure, then replace the lid tightly and set the container in the sun. It should regain its normal shape in an hour or two.

#### How to prevent gas cans from collapsing

"Use modern gas cans with pressure-relief mechanisms and store them on raised platforms to avoid ground heat transfer," advises Nikolin. "And periodically inspect for cracks or warping and replace every 5–7 years for safety." Turner concurs and adds: "Don't overfill them, this can make the whole situation worse. It's one of those things that seems fine until it's not."

#### How to Dispose of Old Gasoline the Legal (and Safe) Way

Don't blow up the house or poison the water. Gasoline is both toxic and dangerous, so it's imperative to dispose of it safely. Here's how.

It might feel tempting to just dump out that little bit of <u>stale gas</u>, but even a small amount can pollute groundwater and pose an explosion or fire hazard. That means it's imperative to know how to dispose of gas properly.

"I've observed gas fumes activating a carbon monoxide detector," says auto enthusiast Alex Black. "Fortunately, no one got harmed, but it might have been catastrophic. Bottom line: even a small quantity of stale gas can pollute groundwater or pose an explosion hazard. Don't play with it. Handle it like a loaded gun."

If you need to dispose of gas safely, here's what to know.

#### Why Proper Gas Disposal is Important

Gas is a toxic substance, which is also dangerous because it is highly flammable. So, when it is disposed of improperly, even a small amount can permanently contaminate groundwater and soil, plus create a fire risk and result in fines and legal ramifications.

#### Local Laws & Regulations on Gas Disposal

Local laws about hazardous waste disposal differ depending on where you live, but all U.S. states classify gasoline as hazardous waste.

"Each county is a bit different, but they all are unanimous in this: no drains, no trash, no backyards," says Black. "In some communities, if you illegally dump it, you'll be fined several hundred dollars, even on an 'oops' moment."

To find out laws for your area, visit the municipal waste management authority website or check the local environmental protection agency website.

#### **How To Dispose of Gasoline Safely**

Contact your local government to learn about hazardous waste programs, drop-off locations, and regulations. Some fire stations will also take it.

"Disposing of gasoline safely is not something that can be done at home," says Julie Bausch Lent, managing editor of **Car Talk**. "Under no circumstances should you dispose of gasoline down a stair or sewer system; you



run the risk of this very flammable, dangerous substance getting into the groundwater or contaminating the ecosystem around you."

To transport gasoline to an approved disposal site:

- Use a red gas can or another gasoline-approved container. Do not use milk jugs or bottles.
- Clearly mark it: "USED GASOLINE DO NOT USE."
- Never mix or dilute gasoline with other fluids.
- Call your drop-off location ahead of time, to make sure they are currently accepting it.
- In the meantime, store it in a cool environment with good ventilation, free from heat and ignition sources.
- Don't haul it in a car with closed windows, and make sure it's secured well before you drive. "I've had trunks drenched from a leaky can, and it's a nightmare to get the gas off, plus perilous," says Black.

#### How To Find Where to Dispose of Gasoline Near Me

<u>Hazardous household waste</u> disposal sites are dependent on your location and your local government. A good place to start is with a Google search for your location and "hazardous waste disposal." You can also ask recycling centers in your area or your trusted local mechanic or visit Earth911.com, which lists drop-off locations by zip code.

#### **FAQ**

#### Can you pour gasoline down the drain?

No. It is illegal and extremely dangerous, plus even small amounts of gasoline can do major damage to water systems and wildlife.

"The presence of gasoline in pipes leads to corrosion, contaminates water sources and produces explosive vapors that can build up inside plumbing systems," says auto mechanic Alan Gelfand. "The violation of these regulations will lead to major penalties and health dangers."

Black also emphasizes that one gallon of gas can contaminate a thousand gallons of water. "And those fumes? If they find a spark in a water heater or from a power tool, boom, it's gonna burn," he says. "I've interviewed fire marshals who've witnessed homes being destroyed by people dumping fuel in storm drains."

#### What should I do if I spilled gasoline?

- Remove any possible flame sources, including lit cigarettes.
- If the spill occurred indoors, open windows and doors for ventilation.
- Secure children and pets away from the area.
- Use cat letter or a spill kit (available at hardware stores) to soak up the spill.
   "Do not pour water on the spill location," says Bausch Lent. "This will only spread it.
- After the material becomes saturated, carefully move it into a sealable, non-reactive container for transporting it to a hazardous waste facility. "The disposal of gas-soaked materials in household trash and the use of water for gasoline spill cleaning are prohibited because they can ignite spontaneously," says Gelfand.
- Scrub the area with dish soap or detergent.
- If the spill is large, consider hiring a professional cleaning service.

"On small spills on garage floors or concrete, spread kitty litter, baking soda or even dry coffee grounds onto it," says Black. "Also, don't wash and dry clothing like you normally would; it's a fire hazard in the dryer. Instead, air it outside, then just toss it if it still doesn't go away."

#### This C7 Corvette ZR1 Race Car Was So Fast It Melted: Video

A heavily modified <u>2019 Chevy Corvette</u> ZR1 recently set a new record at the Big Bend Open Road Race (BBORR) in southwest Texas, sacrificing its rear fascia to the gods of internal combustion in the process.

With driver John Anhalt at the wheel, the white "Tint World" C7 <u>Corvette ZR1</u> achieved an average speed of 173.004 mph in a 118-mile round-trip sprint up and down U.S. Highway 285, between Fort Stockton and Sanderson, besting the previous record of 172.249 mph set in 2013 by Tom Whalen in a C5 <u>Corvette Z06</u>. The record-breaking run was recorded over roughly 41 minutes, with Anhalt pushing the <u>Corvette</u> ZR1 up to a top speed of 213 mph.

After crossing the finish line, the rear bumper on the supercharged Vette was heavily damaged, melting after it was blasted by the intense heat pumped out from the front-mounted <u>6.2L V8 LT5</u>. The combination of an uncorked engine and sustained full-throttle operation earned the car the nickname "Toasted Marshmallow," with the white rear panel crumbled into a distorted mess of crispy, gooey plastic.

According to Anhalt, who purchased the car back in 2020, the ZR1 has been extensively modified to handle high-speed competition. Highlight upgrades include a new supercharger, ported cylinder heads, a larger throttle body, upgraded valvetrain components, Kooks headers, and AWE straight pipes, boosting output by roughly 30 percent over the stock 755 horsepower. The aero was also upgraded, with the car reportedly managing 190 mph in the final corners of the run.

Anhalt was joined by navigator Kelli Hughes, who had originally planned to run her own C6 Corvette, but wasn't quite ready, opting to sit shotgun instead. Incredibly, the ZR1 could have gone even faster, however, Anhalt and Hughes had to carefully manage fuel levels as the thirsty V8 would consume so much of the go juice so quickly, sustained full throttle threatened to drain the tank in less than 20 minutes.

# These Are the Only Highways In the World With No Speed Limit

The U.S. has been limiting vehicle speeds since 1901, when the state of Connecticut became the first to set laws regarding automotive speed. The new law set the limit at 12 mph in cities and 15 mph in rural areas. Fast forward to today, and things have changed drastically, especially in 10 states where drivers can hit the highest speeds in the country, up to 85 mph. However, some thoroughfares in Nevada had no limits for decades, and even as

recently as the mid-1990s, Montana had highways with no speed laws for daytime driving.

Outside of the U.S., limiting vehicle speed has been handled differently. Some areas of the world adopted a no limit policy, and a couple of them have stuck to those policies to this day. Whether it be due to public pressure, local identity, or political distinction, places like the German Autobahn and the Isle of Man are the few remaining destinations free of speed restrictions (mostly). These are the last bastions for performance car or superbike enthusiasts eager to open the throttle fully and experience the true potential of their machines outside of a track.

#### Germany's Autobahn highway system has sections with no speed restrictions

The Autobahn is the national highway system that crisscrosses through the country of Germany. However, it isn't a free-for-all across the entire stretch — there are places where limits are imposed. But the highlight for those with a need for speed has to be the bit between Berlin and Hamburg, which covers 93 miles and is the longest unrestricted section you can find. With no bureaucrats



getting in the way, just how fast do things get on the Autobahn? According to CNBC, sections of Germany's highways have seen drivers surpass 250 mph. Given this much freedom, we wanted your picks for the best Autobahn cruisers. While some of your choices like the Aston Martin V12 Vanquish make sense, others were puzzling, to say the least. So, why doesn't the Autobahn have speed limits in certain places?

In order to understand why Germany's highway system is set up like this, a quick dive into the country's history is necessary. When construction of the Autobahn really began to kick off, it was a propaganda project of the Nazi Party, which did implement speed limits at the time. However, following World War II, the landscape of Europe changed. Germany was divided up into zones, with an eastern portion controlled by the Soviet Union, and the western side occupied by Great Britain, France, and the U.S. Wanting to further distance itself from the communists in the East, West Germany removed speed limits across the region in 1952. While initially all limits were lifted, the lack of speed restrictions in cities became problematic, and the limits were reinstated. Fortunately, the Autobahn (or at least parts of it) was left alone.

#### The Isle of Man features some highways with no speed limit



In between Great Britain and Ireland, lies a small island encompassing just under 221 square miles (572 sq km) that's home to some 84,000 residents. While this wind-swept land offers quaint villages, scenic landscapes, and a robust Celtic history, it's also known for one of the most dangerous motorcycle racing events in the world, The Isle of Man TT.

While peaceful for nearly the entire year, the annual two-week racing event transforms the island.

The race attracts thousands of visitors traveling to see the events, with riders navigating tight two-lane roads lined with stone walls at average speeds greater than 135 mph. However, it isn't just The Isle of Man TT participants that get to careen down its highways at breakneck speeds.

About 30% of the island's highways don't have any restrictions on the books, and this attracts a certain crowd looking for thrills. Considering the island is home to many full-time residents, you may wonder what the locals think of tourists capitalizing on the unrestricted highways. Well, back in 2006, locals voiced their opposition to a plan that would introduce a national speed limit across the island, effectively shutting down the effort, which isn't surprising considering its extreme racing heritage. Speaking with Car and Driver, detective sergeant Allan Thomson with the Manx Constabulary's Road Policing Unit, explained their unique approach to enforcement, saying, "It's all about establishing the idea that if you do wrong, we're going to have a word with you, but we want you to come back next year and tell your friends how good it is."

#### These highways may not offer you the experience you're envisioning

When you picture the Autobahn, for example, the mind may conjure up a wide assortment of exotic sports cars traveling at blistering speeds beyond anything you've ever seen. While this scenario is possible, there's a side of the Autobahn that's seldom shared. For instance, remember that only a portion of Germany's highway system doesn't



have a speed limit, which means you'll need to be cognizant of the laws applicable to the section you're driving, otherwise, there will be penalties. One 199 mph Autobahn speeder got a 3-month driving ban and a hefty fine north of \$1,000 when law enforcement tagged them on radar.

In addition, despite its mystique and appeal, the Autobahn, like any highway, requires maintenance. So, even if you can theoretically go as fast as your car will take you, road construction will certainly slow things down. Can you imagine hitting a pothole at triple-digit speeds? Speaking of slow-downs, you also won't escape the reality of traffic, some of which — like commercial vehicles — is still bound by a speed limit. A large truck certainly isn't going to set any speed records, and it may hamper your cruising abilities as a result.

Unlike the Autobahn, which has some lengthy straightaways with high-speed potential, the Isle of Man's highway system is known for its high number of curves. Apparently, the best chance you have for maximum throttle is a section called Sulby straight, which doesn't quite last a mile.







# What Actually Happens If You Shift Into Reverse While Driving

A common fear among drivers is accidentally shifting to reverse while on the move, which many assume could be catastrophic for the vehicle. But can you really hurt your gearbox if you — or some nosey passenger with a death wish — decide to move from drive to reverse while moving?

If you're driving an automatic car that was built in the '90s or later, you will likely not cause any damage to the gearbox, as the powertrain control module (PCM) in most modern cars will simply not shift into reverse when you're on

the move. A mechanism called a reverse inhibitor stops the gearbox from engaging reverse, even at speeds of around 5 mph. This function is controlled electronically by the PCM in modern cars, while older vehicles used a hydraulic system to achieve the same effect. Putting your car in reverse while driving may cause the reverse camera to turn on (provided your car has one) and the transmission to shift into neutral, all while giving the drivers behind you a scare as your reverse lights come on.

But if your vehicle's reverse inhibitor isn't functioning or your car doesn't have one, the engine will likely stall. Overall, putting your automatic transmission in reverse while driving isn't a good idea, as it can place extra strain on the transmission and potentially lead to substantial damage.

#### What happens if you shift a manual into reverse while driving?



While automatic gearboxes have some safeguards to protect your transmission from eating itself from the inside if you accidentally shift to reverse, manual gearboxes don't offer the same protection — though putting your manual transmission in reverse at speed is nearly impossible, due to the shift lockout that's baked into manual gearboxes to protect them from such abuse. You would have to exert a lot of physical effort and force to shift into reverse while the car is moving, as the reverse gear spins in the

opposite direction of the forward gears.

Putting the car in reverse will likely produce a harsh, grinding noise, and if you're successful in engaging reverse, the engine will likely stall. Synchronizers in manual gearboxes allow smooth and precise shifts between forward gears, but reverse usually lacks a dedicated synchronizer. Moving to reverse from a forward gear at speed will cause the gears to clash, potentially damaging the reverse gear teeth and wearing other transmission components. So, it's simple — if you drive a stick, you'll have to use some muscle to get it into reverse while moving, and if you manage to do it, you'll probably end up with a massive hole in your wallet.



# How To Perfectly Parallel Park Every Time (The Easy Way)

Do you suffer from parallelophobia? If you deal with an irrational fear of parallel parking, you're not alone. Nearly half of all Americans suffer from this condition, and in Britain, many would rather park a mile away than parallel park near their destination.

To help with that, we're going to break down parallel parking into a few easy steps so that you no longer have to fear it. We take this responsibility very seriously at Jalopnik and have done extensive research on the topic, which not only included consulting numerous reliable sources, as well as our own vast experience with parallel parking, but we also conducted some very scientific simulations, as pictured above. We even made "vroom, vroom" noises, you know, for accuracy. And, yes, we keep toy cars on our desk. Don't judge us.

Parallel parking is easier than you may think, even without using fancy backup cameras. Start alongside the car parked in front of your spot. As you back up, cut your wheel to the right once you're half-way past the car parked in front of you. Then, cut your wheel to the left once your front bumper clears the rear bumper of the car in front. Finally, line your car up with the cars in front of and behind you. That's pretty much all there is to it. However, our editor expects us to write a whole article about this, so we'll elaborate with additional helpful details. Ultimately, the key is to take your time while remembering to look behind you and check your mirrors.

#### Entering the space

The first thing you want to do is find the right space. You need enough room to maneuver and to get out of the spot when it's time to leave. So, pick a space that is at least 1.5 times the length of your car. Once you've found your spot, line your car up with the parked car in front of the spot, positioning yourself about 3 feet to its left. Next, flip that turn signal on so people behind you know what you plan to do.



Now you're ready to parallel park. We're going to break this up into four steps. Step one, back up straight until the middle of your car is lined up with the front parked car's rear bumper, and then cut the wheel sharply to the right. Continue backing up. Step two, keep your wheel turned all the way to the right until you are at a 45-degree angle to the curb. Usually, you can tell this is the case when you can see the entire front of the car parked behind you in your driver's side mirror.

Then, straighten your wheels, and continue backing up. Step three, when your front bumper clears the rear bumper of the car parked in front of you, cut your steering wheel to the left. Continue reversing. Step four, when you're aligned with the cars in front of and behind you, position your car an equal distance between the two vehicles to give everyone enough room to get out.

Congratulations, you have parallel parked, one of the automotive skills everyone needs to master. You can release that death grip on your steering wheel. It's okay.

#### **How To Perfectly Parallel Park Every Time (The Easy Way)**



Fortunately, pulling out of a parallel parking spot is much easier than pulling into one, so you don't have to worry about breaking into that flop sweat again at this point. But don't let your guard down entirely. You don't want to pull out in front of traffic or back into the car behind you.

The process is simple, as long as you keep looking behind you and checking your mirrors. First, flip on your turn signal. Then back up to give yourself enough space to pull out of the spot, being careful not to hit the vehicle parked behind you. Look over your shoulder to your left, and check your mirrors to make sure that no one is coming. Once the coast is clear, turn your wheel to the left and enter the street. Be mindful of the car parked in front of you, so that you don't hit its bumper.

As you can see, parallel parking is relatively simple (which might be why drivers haven't bothered to use Ford's parking assist). We should note that lots of drivers get anxious about holding up traffic when parallel parking. But don't worry about the drivers behind you. We mean, worry to the point that you avoid backing into them, but don't let the fact that they have to wait for a minute bother you. At some point, they're going to have parallel park, too. That means that they'll have to rely on the patience of strangers as well. So, take your time, keep looking behind you and checking your mirrors, and you'll be fine.

#### **Explaining Red Light Laws Across the United States**

Confused about what to do at a red light? Here's when it's legal to turn, what flashing signals mean, and who can go through a red light.

We have all been there, <u>sitting at a red light</u> that seems to last forever, wondering if it is okay to turn or if it is safer to wait. Red light laws exist to clarify those moments. They are designed to keep everyone on the road safe, but the exact rules can vary from state to state. After witnessing a few close calls at intersections. I realized that

understanding the meanings of different red lights helps avoid confusion and accidents.

Ahead, you will learn when it is legal to turn right on red, what a blinking red light really means, who can go through a red light, and what the rules say about having red lights on your car.

#### Can You Always Turn Right on Red?

No, you cannot always turn right on a red light. In most places, you can make a right turn after coming to a complete stop, provided there is no sign prohibiting it. You must also yield to pedestrians, cyclists, and other vehicles before making a turn.



According to the <u>California Driver's Handbook</u>, a solid red light means stop. You can turn right only if there is no "No Turn on Red" sign, you stop completely at the limit line, and the way is clear. A red arrow, however, means you must stay stopped until a green light or arrow appears.

#### Which States Can You Turn Right on Red In?

No U.S. states unilaterally prohibit you from turning right on red after stopping. However, there are some exceptions, most commonly intersections with a "No Turn on Red" sign. Those are common in busy areas or spots with limited visibility.

In many west coast states, and in a few others, you can also turn left on red when going from one one-way street to another. California, Oregon, Washington, Nevada, and Texas all allow it, as long as no sign says otherwise. Since the exact rules vary, it's best to check your state's driver handbook before assuming the same laws apply everywhere.

#### What Does a Blinking Red Traffic Light Mean?

A blinking or flashing red light means stop, then go when it is safe. It acts like a stop sign. You must come to a full stop, look both ways, and proceed only when the intersection is clear.

#### When Can You Run a Red Light?

You can't run a red light, period. It's illegal and risky, even if the road looks clear. The only exception is for emergency vehicles (police, fire, or ambulances) when they're using lights and sirens during an active call.

"Also remember that a right turn on red is an option, not a requirement," says Robert Dillman, founder at NEVO Driving Academy. "You can always choose to wait. Come to a complete stop, breathe for a moment, and check the crosswalk, the oncoming lane, and

any movement that might change your plan. Only turn when the space is clear and you feel fully comfortable making that move. Safe driving is never about rushing."

Funeral processions are a gray area. Some states let the first car continue through once the line begins moving, but most require everyone to follow normal signals unless a police escort is leading the group. If you're part of one, it's safest to stop and wait for the green before continuing.

### Can You Have Red Lights on a Car?

No. And for an obvious reason.

"Red and blue lights have long symbolized urgency, which is exactly why they are only



permitted on emergency vehicles or for law enforcement purposes," says Joshua Branch, Founder and Personal Injury Attorney at Law Offices of Joshua W. Branch. "Drivers are not allowed to make upgrades to their vehicles to have red and blue lights because it could cause confusion to other motorists. By making it illegal to use red and blue lights on ordinary vehicles, it allows drivers to quickly recognize a real

emergency responder and take appropriate action to move out of the way as required."

Car lighting rules come from a federal safety standard known as **FMVSS 108**. It outlines what color lights belong where so other drivers can easily tell what your vehicle is doing.

- Red lights go on the back for <u>brake and tail lights</u>.
- Turn signals are amber, and headlights or reverse lights are white.
- Putting red lights on the front of your car can confuse other drivers and, in many cases, break the law.
- Flashing red or blue lights are only for emergency vehicles.

If you plan to add aftermarket or decorative lights, check both federal and state rules first. Lights that flash, change color, or look like police lights usually aren't legal on public roads.

#### Other Red Light Rules You Might Not Know

- **Red arrows:** A red arrow always means stop. You cannot turn until the light changes.
- "Dead-red" situations: Some states allow motorcycles or bicycles to move through a red light if the sensor fails to detect them after waiting a reasonable amount of time.
- "No Turn on Red" signs: These signs override the general rule. If you see one, you must stay stopped until the light turns green.
- **Yielding always applies:** Even when it is legal to turn right on red, you must yield to pedestrians, bicyclists, and any vehicles that have the right of way.
- Vehicle lighting compliance: The same federal standards that govern red lights also apply to all vehicle lighting equipment. Modifying your lights in a way that causes confusion for other drivers can be illegal.

# Is Running a Yellow Light Against the Law? What Drivers Should Know.

Be prepared next time you're entering an intersection.

The <u>traffic light</u> shifts to yellow just as you approach the intersection. For a second,

handyman

everything feels uncertain. Your foot hovers between the gas and the brake. The car behind you is close. You're not sure if stopping makes sense—or if continuing will get you in trouble. It's a moment nearly every driver has faced. But what are the actual rules when the light turns yellow?

#### What a Yellow Light Actually Means

Yellow lights aren't as clear-cut as "green means go" and "<u>red means</u> <u>stop</u>." They signal that red is coming, but that doesn't automatically make it illegal to enter the intersection.

In many places, it's legal to go through a yellow light—if it's safest to do so. The **California Driver Handbook** explains that drivers should stop if they can safely do so, but if not, they can proceed with caution. That's generally how it works in other states, too. Yellow isn't a hard stop, but it is a warning.

<u>Article 38.1</u> gives even more specific direction: if your vehicle has already crossed the stop line when the light turns yellow, you're allowed to keep going. If you haven't crossed yet and can stop safely, that's what you're expected to do.

Still, just because something isn't always illegal doesn't mean it's always safe. In a 2015 **survey** from the National Highway Traffic Safety Administration, 40% of drivers admitted they sometimes entered intersections just as the light turned from yellow to red. Another 11% said they did this often. That kind of behavior starts to push into risky territory. In the same survey, 10% said they sometimes cut in front of other drivers, and 2% admitted they often did.

So where does enforcement come in? If you blow through a yellow light that turns red while you're in the middle of the intersection, a police officer could decide that you ran a red. It depends on the timing, your speed, and how close you were to the intersection when the light changed. **Traffic cameras** work similarly. If the light turns red before your front tires enter the intersection, it's likely going to count as a violation.

#### Why Yellow Light Timing Matters

Yellow lights don't last the same amount of time everywhere. Some give you enough room to react. Others flip to red so fast that even careful drivers can get caught in the middle.

According to the <u>Insurance Institute for Highway Safety</u>, adding just one second to yellow lights in Philadelphia reduced red light running by 36%. Most people aren't trying to break the law—they just misread the timing. A slightly longer yellow gives drivers a better chance to stop or pass safely.

The Institute of Transportation Engineers has suggested standards, but not all cities use them. That's why some intersections feel rushed, even if you're doing everything right.

#### Is It Illegal to Enter an Intersection During a Yellow Light?

If you're ever in doubt, it helps to think about the purpose of the yellow light. It's there to give you time to stop. If you're already too close to the intersection to stop without slamming the brakes or getting rear-ended, the expectation is that you'll keep going. But if you've got space and time, stopping is usually the better call.

Yellow lights aren't a free pass, but they're not usually illegal either. It all depends on how fast you're going, how close you are, and whether you can stop safely. Every intersection is different, and the rules only go so far. A yellow light means you have to make a quick decision and whether it's the right one depends more on your timing than the law.

Ultimately, every country and state has unique driving laws, so verify the laws where you're driving
