Tournament Rules

- 1. Bowlers must be current USBC members to participate.
- 2. Participants in doubles event shall also enter the singles event, vice versa. Participants shall bowl in the same order as listed on the entry form. Participants shall bowl singles first followed by doubles.
- 3. Multiple participation is allowed in the Teams, Doubles, and Singles events with the following provisions:
 - a. Teams must change two (2) players to bowl each additional team.
 - b. A participant may bowl multiple sets of doubles by changing partners.
 - c. Participants may cash more than once in the Teams and Doubles events.
 - d. Participants may cash only once in the top 10 of the Singles event.
- 4. Participants may only enter the All Events Handicap and All Events Scratch events one time. A participant's first appearance in the team, doubles, and singles events will count towards their All Events scores.
- 5. Entering average will be the highest single USBC league from the previous two seasons average based on a minimum of 21 games. Bowlers without these averages may use a current season average of 21 games or more. Bowlers without any of these three averages must bowl scratch.
- 6. It is each bowler's responsibility to verify the accuracy of their own average, whether originally submitted by the bowler, the team captain or others. Failure to use the correct average may disqualify the score if submitted average is lower than correct average. Prize winnings will be based on the submitted average, if it is higher than the correct average (Rule 319a-3).
- 7. Handicap shall be based on 90% of the difference between the entrant's average and a scratch figure of 210. Each event is to be handicapped on a three (3) game basis.
- 8. Teams may be composed of all men, all women or mixed with a playing strength of four.
- 9. Prize payout is at least 1 in 5 for bowled events, 1 in 10 for all events. Prize fee returned 100%
- 10. Except where covered above, the tournament rules shall be governed by USBC Playing Rules Chapter 6-Tournament Rules with the exception of rules: 301, 302, 309b, 309c, 313, 314, 317, 318, and 323.
- 11. All other matters not covered by the above rules are at the discretion of the tournament director and management of Sunset Lanes. All decisions of the tournament manager are final unless an appeal is made in accordance with Rule 329.
