The Seller Agrees:

That this puppy is in good health at the time of sale. The buyer will have 72 hours in which to have the puppy examined by their own veterinarian. If the puppy is found to be ill by a licensed veterinarian and is to be returned due to illness, a letter from the veterinarian is required. This includes death or illness from any health condition deemed to be present prior to leaving the seller's premises. Buyer shall assume any expenses associated with returning the puppy to the seller. The seller will, at the seller's discretion, refund the purchase price, return the puppy to buyer in healthy condition, OR exchange the puppy for another puppy of equal value. At no time and under no circumstances will the seller be responsible for any veterinary expenses incurred by the buyer.

This puppy is warrantied against fatal hereditary/genetic defects and disorders for 2 years from date of purchase.

Should this puppy be determined to be suffering from a fatal defect deemed to be hereditary (within two years from the date of purchase), breeder will replace the puppy with one of the same value when one is available. Replacement will occur after notification and written verification has been furnished to the breeder by TWO independent veterinarians. The breeder will not be responsible for any veterinary costs at any time.

We cannot guarantee that your puppy will never develop any health problems, just as a pediatrician cannot guarantee that a child will never develop any health problems in the future. Some things are just not predictable. Our parents are genetically/health tested and free of diseases, disorders, and health problems; otherwise we would not breed them. That means our puppies are less likely to develop any genetic problems. If anything does occur, you are required to inform us so we can evaluate the parents and other puppies from that litter in an attempt to determine the cause of the ailment and eliminate the issue from our breeding program.

Breeder does not guarantee against coccidia and giardia, (typically a dormant single celled parasite common in puppies) or any other parasites. We do our best to keep the puppy parasite free and use preventative and deworming treatment schedules on our parents and puppies. Parasites can be easily picked up anywhere outside, so we highly recommend keeping your puppy on a deworming schedule throughout their life. We also cannot guarantee final adult weight or color. We can only estimate color from what puppies show before leaving us, and size by limiting factors of dad being 40lb poodle and mother being 65lb F1 bernedoodle. Nature still takes its course and some things are out of our control. Thanks for your understanding.

The Buyer Agrees:

That this puppy will be given adequate and proper shelter as well as housed securely. The puppy shall not be neglected, allowed to roam free, or be mistreated in any manner. The puppy shall receive proper veterinary care throughout its life. The puppy shall receive proper nutrition and care shall be taken to maintain its proper weight. Buyer agrees to give the dog proper training and socialization.

Buyer agrees not to breed this dog. This puppy is required to be spayed/neutered by 1 year of age and a copy of the spaying/neutering info, vet bill or vet records sent to the seller. Should we not receive confirmation of the puppy's spaying or neutering after puppy turns 1 year of age, as original purchaser, you will then be liable for the puppy's full purchase breeding value, which can be up to three times higher than purchased pet value, plus all the attorney and court fees involved.

No guarantees or warranties expressed or implied are given by the breeder, except those stated herein. Breeder warranties and agrees that they are the lawful owner of this puppy and are alone responsible for entering into this contract with the Buyer.
