I hereby agree for and on behalf of myself, my dependents, heirs, executors, administrators, and assigns to use utmost care when handling, using, or in the presence of, any equipment belonging to the Tulsa Youth Keyboard Orchestra, Inc, its sponsors, officers, agents, volunteers, licensees and representatives. I also agree that any damage incurred to any equipment/instruments while in my possession, during rehearsals and performances, will be the sole responsibility for full replacement value and/or replacement/repair costs to the parties signed below, occurring during any portion of, or in relation to this program.

Waiver and Release

- 1) In consideration for participating in the Tulsa Youth Keyboard Orchestra, I hereby release, waive, discharge and covenant not to sue the Tulsa Keyboard Orchestra, their officers, board of directors, sponsors, volunteers, agents, employees, licensees and representatives (hereinafter referred to as Releasees) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.
- 2) I further hereby agree to indemnify and hold harmless the releasees from any loss, liability, damage or costs, including court costs and attorney’s fees, that may incur due to my participation in said activity, whether caused by negligence of releasees or otherwise.
- 3) It is my express intent that this release and hold harmless agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns, and personal representative, if I am not alive, shall be deemed as a release, waiver, discharge and covenant not to sue the above named releasees. I hereby further agree that this waiver of liability and hold harmless agreement shall be construed in accordance with the laws of the State of Oklahoma.
- 4) I understand that the releasees will not be responsible for any medical costs associated with an injury I may sustain.
- 5) I also understand that I am responsible for any damage I cause to the facilities (rehearsal and performance venues). In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement and understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent, or will be executed by a parent or legal guardian on my behalf; and I execute this release for full, adequate and complete consideration fully intending to be bound by same.
