# TRIBULATION PERIOD TIMELINE

## PIVOTED ON NISAN 10, 2029

The Start of Daniel's 70th Week?

As many of you may know, one's Tribulation Timeline has had the Start and End Dates correspond to 2 Key Sabbaths. Presumably, it is currently one's Calculation, if the Fall of 2025 is when the Tribulation Period is to begin. If so, then one has surmised that the Sabbath occurring after Simchat Torah would or could be that Start Date for Daniel's 70th Week to begin. For 2025, that Weekly Sabbath falls on October 18, 2025. And?

That Weekly Sabbath is known as the 'Sabbath of Beginnings'. Well, this is where, if one then adds the 2 Halves of the 1260 Days or 42 Months of 30 Days each, the Mid-Point will land on March 31/April 1, 2029, which is Passover. This is also then presumably when the Daily Sacrifice will cease. Now if this is the case or will be, consider that if the Tribulation Period starts just after a Shemini Atzeret, of a given Year, say 2025? That would correspond or would have to correspond to when the Abomination of Desolation is done and the Daily Sacrifices are stopped, at a Passover.

And what better Time than to insult YHVH than to have it be during the Passover Lamb Sacrifice. It would be a direct Insult to Jesus, etc. And then it is the Place and Time, wherein, the 'Great Tribulation' commences. It is also when the Revelation 12 Sign actually is fulfilled, astronomically in one's Calculation. It will have to do with Planet X and how one has pointed-out that at the 2nd Passover of 2032, there will be a Blood Moon. Here is the Present Tribulation Timeline that is bracketed by the 2 Sabbaths.

OCTOBER 18, 2025 (SABBATH OF BEGINNINGS)

+1260 Days

MARCH 31, 2029 (PASSOVER)

+1260 Days

SEPTEMBER 11, 2032 (SABBATH OF RETURN)

This Half-Way Marker will be typified by the Woman, as the Believing Jewish Remnant flees to the Wilderness. This will be the 'Exodus 2.0', etc. And the Terminating Sabbath is known as the 'Sabbath of Return'. That Date corresponds to September 11, 2032. (9-11). So, as one can see, this is why one has been very interested and excited about this Timeline, if accurate. The issue is that the September 11, 2032 Sabbath of Return is not on Yom Teruah, or the Feast of Trumpets. One is assuming, and is of the Belief, that Jesus will return on a Yom Teruah Feast Day. So, is there a 'Better' Timeline?

## The Beginning of the End?

The Key is having Jesus return on a Yom Teruah. It is because one is of the Opinion that the 7 Main Feasts of YHVH, as the Menorah Pattern attributes, are being fulfilled by Jesus, succinctly. After the Return of Jesus on Yom Teruah, He will also fulfill in Sequential Order, the 2 Remaining Feasts of Yom Kippur and then Sukkot, etc. So, as one has revisited the Fall 2025 to Fall 2032 possible 7-Year Tribulation Period Timeline, one has synchronized the 2 Time Intervals of 1260 Days to Nisan 10 of 2029. Why?

As there had been much Anticipation of the 70th Week of Daniel commencing on Nisan 10 in 2025, what if one recalibrated one's current 7-Year Tribulation Timeline to that Pivotal Date? Here is what one found and is sharing. Note one's '723' Rapture Code. In one's Alternate Interpretation of the '723' standing for July 23, the Numerical Values in this case correspond to the 7th Jewish Month, Tishrei and the 23rd Day.

Here is the Key. For 2025, Shemini Atzeret occurs on October 15. It so happens that October 15, 2025 in the Hebrew Calendar is Tishrei 23 or '7-23'. Coincidence? And 1260 Days later is Nisan 10 in 2029. Then 1260 Days later is Yom Teruah, precisely on September 6, 2032. Will this Timeline see the Return of Jesus at this Time and Place? Time will Tell.

AS NOTED: Israel's 70th Birthday + 723 Weeks = Nisan 10, 2032.

- = Tishrei 23 (723) Shemini Atzeret (October 13, 2025) Start of Tribulation?
- + 1260 Days
- = NISAN 10 (MARCH 26, 2029) 4 Days later is Passover.
- + 1260 Days
- = YOM TERUAH (SEPTEMBER 6, 2032) Return of Jesus?

Also realize that the October 7, 2023 Hamas Attack against Israel was on Shemini Atzeret. And? Many End Times Students of Prophecy suggest this Date began the Countdown. Perhaps it was and is the Countdown to the End of the Church Age, which concludes the Commission with the Rapture. And then soon after, the start of Daniel's 70th Week of Years, i.e., the 7-Year Tribulation Period begins. Then consider that if one adds 666 Days from the Hamas Attack back in 2023, the End Date is the 9th of Av in 2025. You cannot make this up. As it has been said, 'Something Biblical is going on here'.

October 7, 2023 Hamas Attack + 666 Day Count = August 3, 2025 (9th of Av)

#### Day of Jewish Calamity

As one may know and note, the 9th of Av is a Day of Calamity for Israel. It is where the Report of the 10 Spies, save Joshua and Cale, made the whole Congregation of Israel fearful and not wanting to believe YHVH and enter the Promised Land, etc. This was when Moses sent a Reconnaissance Team of 12 Spies to survey the Promised Land. Due to the Nephilim Tribes positioned there by Lucifer, the 10 Spies dissuaded the entire Congregation to relent because of the Giants in the Land.

Lucifer did not want and does not want the Land of Israel to belong to the Jews as intended by YHVH, etc. Mission Accomplished. So, Fear kept the Israelites from entering and not wanting to Believe the Promises of YHVH. That whole Generation forfeited their possessing their Allotted Inheritance. And the Struggle for the Promised Land has continued ever since. The 9th of Av is also when the 1st Temple and the 2nd Temple of YHVH were destroyed, by Babylon and then Rome, respectively.

In Summary, what if this sort of Date Countdown will have to do with a similar Event and Outcome? Say, the start of Daniel's 70th Week, perhaps? As it was pointed-out, Israel's 70th Birthday + 723 Weeks = Nisan 10, 2032. As noted, for 2025, Tishrei 23 or '723' is Shemini Atzeret. It corresponds to October 15, 2025. Then, if one adds the corresponding 1260 Day Counts, the Mid-Point would land on Nisan 10, 2029. This is the Date commemorating the Triumphal Entry of Jesus into Jerusalem.

And then 4 Days later, as the Passover Lamb was to be inspected for 4 Days, Jesus literally became that Passover Lamb. Then 1260 Days later would actually be Yom Teruah, on September 6, 2032. Could this Timeline then better coincide with the Return of Jesus in fulfilling the Prophetic Feast Types in Sequential Order? Thus, could this alternative 7-Year Tribulation Timeline be the more accurate one? But also one must realize, that if one 'accepts' this Nisan 10 Pivot Time Marker that hinges the entire 70th Week of Daniel, then one must accept that Jesus is to return then on Yom Teruah, no?

It would fulfill the 7-Feast Pattern in its Order. As to the Start Dates from Shemini Atzeret in 2025? As you all may know, the Jewish Day starts on the previous Day at Sundown. And in this case of this Minor Feast, it is a 2-Day Event that then dovetails with Simchat Torah. So, depending on what Day one is choosing from, it can be October 13, its Beginning or October 15, its End, etc. But as one has also shared, could this be the Time when the 3rd Temple is to be dedicated? One's Theory is that the 'Covenant with the Many', is the Mosaic Covenant and the 'Many' are the L'Rabbim or the Elders of Zion.

In this Modern Context, it is the Reconstituted Sanhedrin that their Jewish recognized Messiah will then 'Confirm' and sanction the Building of the 3rd Temple. Not only that but he will then Dedicate it with the Initiation of the Daily Sacrifices. As you all may know, one has shared how the Daily Sacrifices are what starts the 2520 Day Count. This would also follow the 2 Major Prior Patterns recorded in the Bible, of when the 1st Temple and the 2nd Temple were Dedicated, in the 7th Month.

#### **Noahide Laws**

Here is a Chart one made to show how the Building, the Dedication and the Destruction of the Temples of YHVH have all occurred in the same Month in relation to each Event. This is astonishing. And that this Triangulation follows the approximate Phi Ratio of Patterns. This Sacred Gematria Association is not a mere 'Coincidence' in one's Mind.

So, yes, to reiterate, Shemini Atzeret in 2025 begins at sundown on October 13 and ends at Nightfall on October 14. This Holiday is observed as the '8th Day of Assembly' and is then associated with the Reading of the Torah, called 'Simchat Torah'. In one's Mind, what an Opportunity to 'Confirm the Covenant', i.e., the Law of Moses as Israel is put 'Under the Law' to finish-out the last Remaining Sabbath of the Land still owed to YHVH. etc.

But consider this, so, perhaps the entire 7-Year or 2520 Day Count Tribulation Period is hanging or pivoting on this Nisan 10 Date Marker of March 26, 2029. If it be, consider that we have perhaps 'Cracked the Code' then of the more accurate if not the 'True' Day Count of when Daniel's 70th Week of Years; of when it is to Begin, be Interrupted and End. #### Mark of the Beast
