NEW WINE RAPTURE AT END OF SUMMER INSTEAD?

FIRST FRUITS OF THE HOLY SPIRIT

When the Wheat meets the Wine

The study is to consider why the timing of the Rapture has to coincide with a First Fruit Festival. It has to do with when the Holy Spirit came down and indwelt the Believers and Followers of Jesus. One has argued that it was precisely on the Feast of the First Fruits of the New Wine. And? So was the Holy Spirit's 'Deposit' or Seal. This is why one is more convinced that when the Church Age ends, the Commission will coincide on its Anniversary. The Holy Spirit was given to the Church as the First Fruit.

It is because it coincides with a First Fruit Feast. And that First Fruit is of the New Wine. This is what the Acts 2 Pentecost was all about and will be, in one's estimation. Obviously, as theories go, one can be incorrect. But one's '723' July 23 Rapture High Watch Date of mine is only just that. It is one's best guess and calculation from years of study. Since I had that 'Vision' or Dream about the number '723' appearing with a brush stroke across a grey blank canvas, I have just ran with it.

It occurred twice as the 1st time, apparently one did not pay enough attention to it. One just shared it with a Rapture Online Community to get council about it. But in the subsequent research over the years, it seems that this July 23 is significant, appealing in more ways than one. Can it be the day that the Dominos begin to fall instead of the Rapture? Sure because it is the Leo New Year, so yes as in 'New Beginnings', etc. But as you mentioned that the Rapture could perhaps not take place until the end of the Summer?

That corresponds to September 22, 2025. As we are well versed, that is the Eve of the 8th Year Anniversary of the Revelation 12 Sign. And the assumption back in 2017 and/or perhaps now again, it was that because it does have a Rapture component to it. Perhaps, could this event and date be when the Rapture of the Bride is to take place instead? And coincidentally, it is Tishrei 1 or the Feast of Trumpets, or Yom Teruah for 2025.

So, if July 23 comes-and-goes, this next Rapture Roulette Date is something to consider. Now here is one's question about how it may not be the case for a Rosh HaShanah Rapture. But for those that are fixated that the 100th Trumpet Blast is that 'Last Trump' of the Rapture, then those Brethren are smiling with glee. One cannot blame them. So, here is the Deal. If one looks at Israel, then yes. Based on Hosea, the Summer Fruits will have been harvested by the end of Summer, September 22, 2025.

First Fruit Resurrections

The Resurrection Order is based on First Fruit time markers. And here is the issue. It is and will be Israel that is not saved, not the Bride. As you all know, interwoven into the Theory of the Pentecost being the New Wine, is that one has pegged the First Fruit Feasts with the Order of the Resurrection. Jesus fulfilled the First Feast of the New Barley with His Resurrection. He also fulfilled the First Fruit of the New Wheat with His Ascension. Thus, if the Pattern is True and Valid, then the next Order of the Resurrection, which will be or has to be His Body, His Bride has to coincide with the subsequent First Fruit Feast. And that is? New Wine.

ORDER OF THE RESURRECTIONS

- 1. First Fruit: Barley Jesus' Resurrection in April
- + 50 Days
- 2. First Fruit: Wheat Jesus' Ascension in June
- + 50 Days
- 3. First Fruit: Wine Body/Bride of Christ in July

Now, as you all know, we have a 'Brotherly Beef' amongst myself, Brother Tyler and Dr. Awe about how one calculates the Pentecost New Wine to be, precisely on July 23. But Tyler and Dr. Awe calculate the timeline to stretch-out to Av 9. If one plainly interprets that one is to count 'Complete Sabbaths' from the Morrow after the Sabbath, then the following if one take the calendar days for April 2025.

Passover = April 12 a Saturday

Day After = April 13 a Sunday

One's point is that there is no need to skip an entire week as the Brethren do because by Sunday is already 'complete'. It means that April 14 is Day 1 of the 49 Day Count and then the subsequent 50 Day Count. Thus the following.

April 14, 2025

- + 50 Days
- = June 2 (This was the 153rd Day of the Year and the Jewish Shavuot.)
- + 50 Days
- = July 23, 2025 (Lu's Pentecost New Wine Date and Rapture Watch)

9th of Av New Wine Rapture?

Here is one's issue and the problem with Av 9 being pegged to being the Pentecost of Acts and the New Wine Feast. It is simple math that disproves an Av 9 Pentecost being that and New Wine. Let us consider the start date that is being used to get to Av 9 Pentagon New Wine. If one uses the Day of the Resurrection, being Nisan 17 or April 15 to Sivan 15 is not a 50 Day Count. Sivan 15 = June 11. So, from April 15 to June 11 is 57 Days, not 50.

You cannot add 1 entire week based on a faulty misinterpretation just to make it a 'Complete Sabbath'. One's point is that the only way to arrive at an Av 9 Pentecost and New Wine is to have added a whole week of days, to have started from April 20. In one's humble opinion, this is incorrect. Even using this 'Complete Weekly Sabbath' count, it does not take one to Av 9. As to the World Economies falling and the 2-State Solution needing to take long?

It would look that way but consider the saying about how things or events happen...'Gradually and then Suddenly'. Say, if July 23 is the Rapture Date, it would be about 3 Months before the Tribulation Period starts. But again, this scenario is based on one's Interpretation of the Last Days, etc. But did you all notice and see how the Religious Jews have now posted the Traffic Signs pointing to the 3rd Temple?

One's point is that after the Rapture Reset, the building of the Temple will only take a matter of weeks as the Jews have to act fast. It is reported that essentially the Temple is now all ready, prefabricated and just needs to be assembled on the Temple Mount. This will occur once the AntiChrist makes the 'Decree' to do so when he will also 'Confirm the Covenant with the Many'. And as one asserts, this 'Confirming' is of the Covenant that already exists. It is the Law of Moses, i.e., the Mosaic Covenant. One would agree that 33 AD is 1 year too late for the Rapture. Here is why.

Consider that if Jesus was in His 33rd Year completed by the time of His Crucifixion, it means that He had to be born in Year '0'. And that is not likely, statistically. One finds it rather contradictory that those Brethren that assert that the Crucifixion was in April of 33 AD, also assert that Jesus was born in -4 BC. This Year Count would make Jesus then 36+ years old at the time of His Death. And the 'Blood Moon' was not a Blood Moon as the eclipse was not total in comparison to the one that was in 32 AD, etc.
