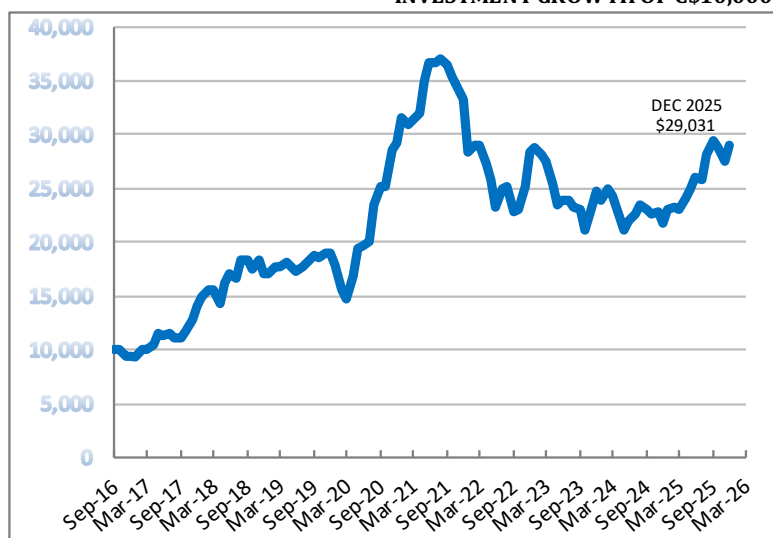

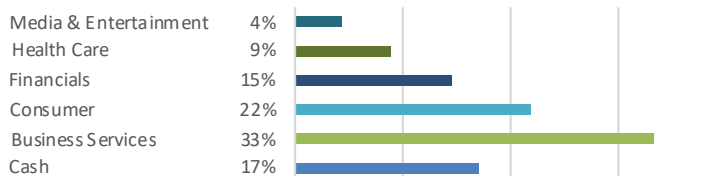
### INVESTMENT GROWTH OF C\$10,000

We invest in global companies with a **margin of safety**, which is the difference between the intrinsic value of a company and the price paid. We aim to uncover and invest in companies that have long-term growth potential, strong business fundamentals, and are typically owner operated at a discount to their intrinsic value. We conduct our research and **invest like business owners** and place great emphasis on the alignment of interest between management and shareholders.

We believe that a permanent loss of capital is the primary source of risk and not market volatility. At Tempered, **market volatility is embraced** and not shied away from. Short-term mark-to-market decline in security prices provides us with investment opportunities. To capitalize on these opportunities, it is essential for our clients to share our multi-year investment horizon as these volatile situations may occur regularly and can last for an extended period of time.

Furthermore, we believe in managing a **concentrated portfolio** of companies to enable us to focus on the most compelling investment opportunities. By managing a concentrated portfolio, the risk of capital loss can be reduced when investing in companies that trade at a
