There were some small fires lit by wind driven embers on the west of Shoal Line but they were rapidly noticed and extinguished. The main blaze was contained to the preserve through the diligent efforts of all the first responders. They managed to contain the fire and get it under control with no damage to any buildings. Following a discussion with the Board of Directors, I sent a letter expressing HBPOA's appreciation to Hernando County Fire and Rescue (HCFR) Chief Paul Hasenmeier. We will also more personally thank our own HCFR Station 6 personnel by providing them with a meal as soon as those logistics are worked out and by inviting some representatives to be our guests at an upcoming meeting.

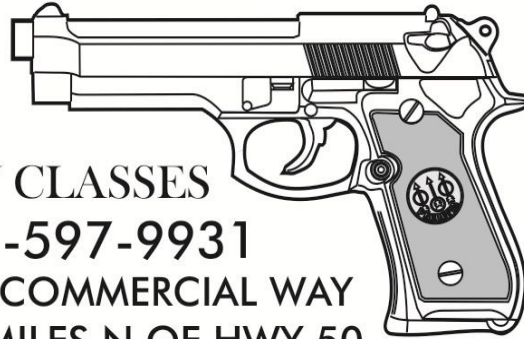

The Florida Forest Service – Withlacoochee Forestry Center is currently responding to a wildfire of undetermined size off of Shoal Line Blvd / Petit Lane, in Hernando Beach, Hernando County. **Hernando County Fire Rescue** is on scene. No structures are threatened. Please avoid the area to ensure emergency crews have safe and clear access.

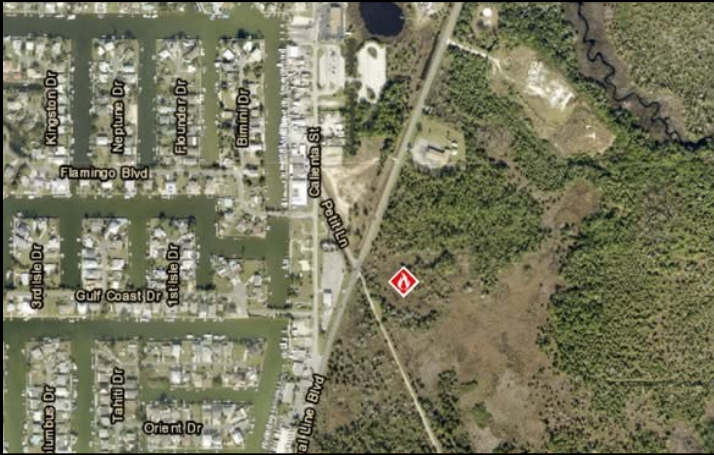
Forest Service - Withlacoochee Forestry Center actively fighting brush fire. The wind is not in our favor. Please avoid the area and move over for emergency personnel.

The wildfire remains at 120 acres and is now 90% contained. Crews from the Florida Forest Service – Withlacoochee Forestry Center are currently conducting mop-up operations and will remain on scene throughout the day. Residents may continue to see smoke and smoldering as remaining hot spots are extinguished.

A huge thank you goes out to **Hernando County Fire Rescue, Pasco County Fire Rescue,** and the Hernando County Sheriff's **Hernando County Sheriff's Office** for their rapid response and for protecting numerous structures during this incident.

March 30 at 4:23pm

Wildfire Update – Shoal Line Blvd

As of 4:10 PM, 3/30/2026 the fire remains at 120 acres and is now 100% contained. FFS–WFC crews have applied 3,400 gallons of water to remaining hot spots. Smoke and smoldering may still be visible, which is normal.

Hernando County Fire Rescue will monitor the area overnight, and FFS will continue checking the site over the next several days. All crews will be released shortly.



April 1 at 3:31pm

Wildfire Update – Shoal Line Blvd

3:17 PM • April 1, 2026

Hernando Beach, Hernando County

The fire remains at 120 acres and is now 100% contained. FFS–WFC crews applied another 2,700 gallons of water to remaining hot spots.

Some smoke or smoldering may still be visible — this is normal. Internal pockets of duff may continue to burn beneath the surface.

Safety Reminder – Burned Area Hazards

Please stay out of the wildfire burn area. Recently burned forests are extremely dangerous due to falling trees and snags (standing dead or weakened trees). Fire-damaged roots and trunks can fail without warning, even on calm days.

For your safety and the safety of our crews, avoid entering the area until officials announce it is safe to return.

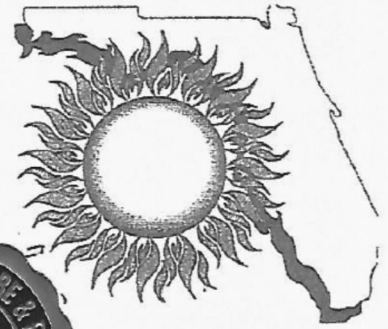

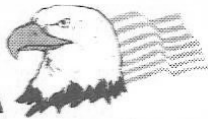
