ther mentioned that locally owned businesses should also begin their preparations and share their emergency business plans with employees. Here are some “Low-Cost and No-Cost Preparedness Tips for Floridians”:

**Make a Plan** – Every household should have a disaster plan that is specific to the needs of everyone in their household, including children, pets, and seniors.

**Know Your Zone, Know Your Home** – It’s important for residents to know if their home is in an evacuation zone, a low-lying, flood-prone area, a mobile home or an unsafe structure during hurricane season. Visit [FloridaDisaster.org/Know](http://FloridaDisaster.org/Know) for more information and to find your zone.

**Have Multiple Ways to Receive Weather Alerts** – Residents should have multiple ways to receive weather alerts and follow all orders from local officials. Every household is encouraged to have a battery-operated or hand-crank weather radio to ensure they can continue to receive alerts from the National Weather Service in the event of power outages or damaged cell towers. Sign up for Alert Hernando by visiting [www.AlertHernando.org](http://www.AlertHernando.org)

**Halfway Full is Halfway There** – Residents and visitors are encouraged to keep their vehicle’s gas tanks at least half full during hurricane season to ensure they have enough fuel to evacuate tens of miles as soon as possible without worrying about long lines at gas stations and to avoid gas shortages prior to a storm. For Floridians with electric vehicles, it’s recommended that the battery be maintained between 50% - 80% capacity at all times, depending on the type of vehicle and what the vehicle’s manual recommends. Hernando County’s Division of Emergency Management Annual Hurricane and Safety Expo will be held on Saturday, June 3, 2023, at Challenger K-8 School located at 13400 Elgin Blvd., Spring Hill. Our May guest speaker was Chief Paul Hasenmeier, the Public Safety Director/ Fire Chief for Hernando County Fire and Rescue. The Chief said his mission is to maintain a fire department capable of sending one of several focused response teams in response to emergencies that require specialized capabilities to save lives and

property. He is also charged with maintaining an Emergency Management capability with the required experts and professionals providing Disaster Planning, Disaster Response and Disaster Recovery. Chief Hasenmeier spoke about his manning, budget concerns and the explosive growth of Hernando County. He noted that about 1000 people a day are moving to Florida. In budget planning, the county was planning to grow the fire department to serve a population of 205,000 by 2025. Incredibly, the Hernando County population is already at 206,000. The county currently has 14 fire stations with two on the drawing board. His budget and personnel concerns focus on renovating existing fire stations, and building two new ones in areas that are growing with new housing developments – response time is key providing rapid response to save lives and preserve property. Locating fire stations in densely populated areas is essential and planning that takes insight. Chief [Hasenmeier](#) stated that he’s sent 15 fire fighters annually to EMS training and this year he’s attempting to send 30 to address the increased demand. Seventy percent of fire station responses are EMS related in addition to fire and rescue calls. For

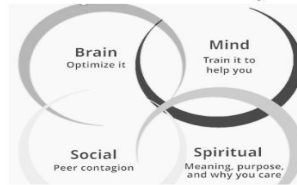

Hernando Beach, Station 6 must meet codes for a flood zone so it was designed to meet that code and is elevated on stilts. He said they are working towards a June 2023 opening date – look for the announcement.

We had a question from the audience who asked what the calls were for Hernando Beach – He said over the past year, they responded to 485 calls, 322 were medical, 17 vehicle crashes, a water rescue and false alarm. He added that due to new construction materials, the time from first alert to total engulfment of the structure decreased dramatically. He emphasized “check your smoke alarms.” Thank you Chief Hasenmeier for an informative and educating presentation.

I found this regarding your fire alarms. According to a Consumer Report article, the life expectancy of smoke alarms is generally 10 years, after which point, their sensors can begin to lose sensitivity. The test button only confirms that the battery, electronics, and alert system are working; it doesn't mean that the smoke sensor is

working. To test the sensor, use an aerosol can of smoke alarm test spray that simulates smoke. But even if the over 10-year-old smoke alarms in your homes can still detect smoke, they recommend replacing them with new models.

On the lighter side, our Guest Hernando Beach Business highlighted at our meeting was Barbara's Stained Glass Workshop. She had on display some beautiful examples of her work. She said she has taught stained glass classes for 10 years in her home every Tuesday, Wednesday and Thursday, and would love to welcome you! cal news highlighting the high number of accidents, hypothesizing causes, what can be done and taking that message to Hernando County Officials. Mike Fulford raised the issue about the future disposition of the Triangle. He stated that we'd need a memorandum from the HBPOA to the County Administrator through the Director of Public Works, Mr. Scott Herring. Denis Polyn made a motion to return the Triangle to the County, the motion was seconded by Linda Tartaglione. We had a vote and the membership voted all in favor. As a result, the HBPOA Board will investigate the process to return the Triangle to the County and report back to the membership. The HBPOA does not have liability insurance and the continuous repairs are beyond the scope of our ability and budget to shepherd the location with watering, lighting and plants which are significantly different than replacing lights every two weeks, replacing landscaping and accident damages.

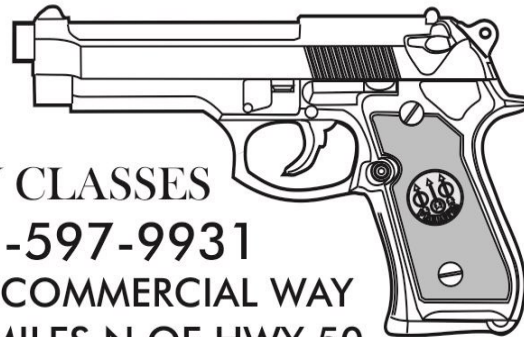

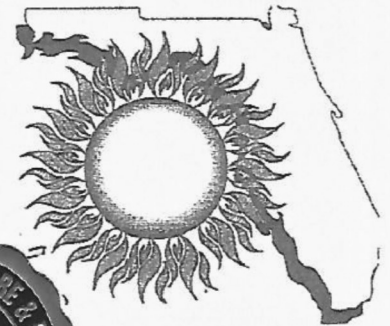

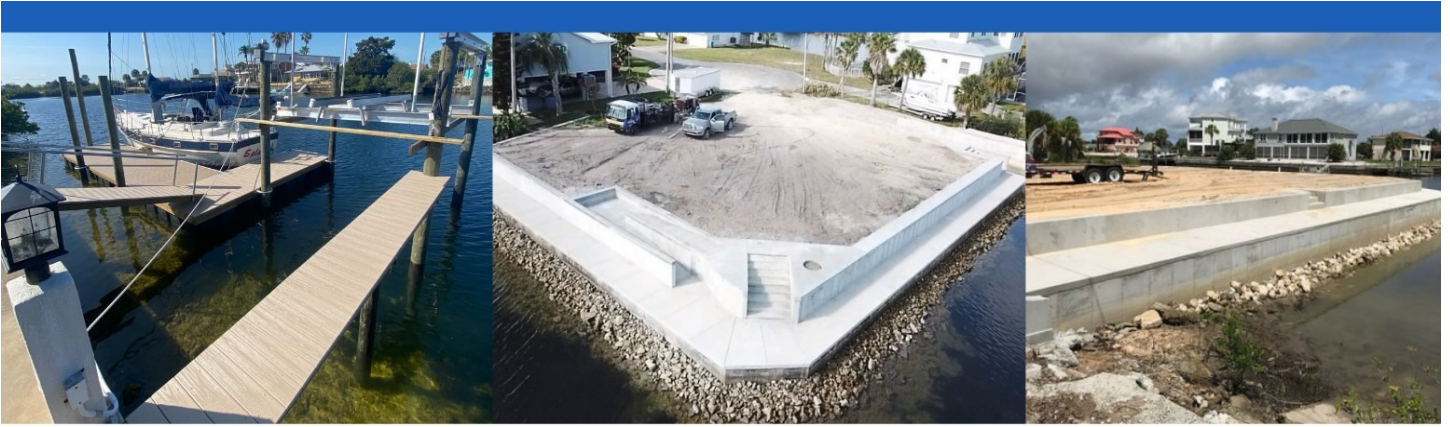
