PRESIDENT'S MESSAGE

Greetings fellow HBPOA members. I hope you are enjoying our Florida Spring and the opportunity for more outdoor activities on both land and water that come with it. Winter is now thankfully well behind us in spite of how hard it tried to keep hanging on! Finally, "should I run the pool filter all night and maybe let the hose bib drip" is no longer a necessary calculation before turning in for the night. March ushered in Spring with increasingly pleasant days, delightful evenings, and finally no more prolonged hard freezes overnight. Let's hope that the pleasant weather continues through April and well into May before the inevitable Summer humidity sets in to stay.

April is generally regarded as a time of renewal and growth. Did you know that the derivation of the month's name is most likely from the Latin word "aperit" meaning "to open" as in the emergence and unfurling of buds, leaves, and flowers. We've all heard the ditty that "April showers bring May flowers". Although our rainy season doesn't typically kick in until late in May or June let's hope that we do see significant "April showers" this year to help with the major rainfall deficit we are currently experiencing.

The current drought has been described as the worst in about 50 years. Combine that with the ever increasing demand for water as Florida's population has grown and you can appreciate the scope of the problem. As you are probably aware, water use restrictions are in place here in Hernando County and all around us. So please do your part to conserve water where you can and to adhere to the water use restrictions currently in place. Lawn irrigation is only al-

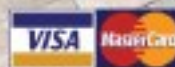

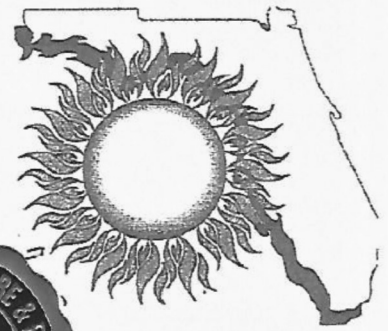

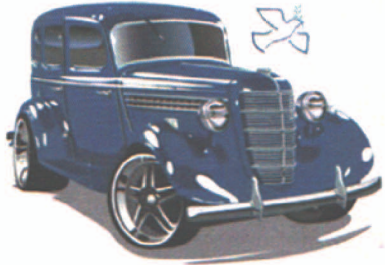

Stash the Trash

Make your own trash bucket for your boat or kayak with these easy steps:

Supplies

1. Bucket with lid
2. Utility knife or hole saw
3. Rope or paracord
4. Carabiner



1. Choose any size bucket or plastic container with a lid, like the 5-gallon plastic bucket or coffee container pictured

2. First, mark & cut a hole in the center of the container lid to allow trash to pass through, but not blow out. Additional lines can be cut from the hole towards the outer edge of the lid.



3. To help secure the container onboard, add a length of rope or cord with a carabiner.

BOATING SAFETY REQUIREMENTS

- Anyone born on or after January 1, 1988 who operates a vessel powered by 10 horsepower or more must pass an approved [boater safety course](#) and have in his/her possession photographic identification and a boating safety education identification card issued by the Florida Fish and Wildlife Conservation Commission.
- The following operators are exempt:
 - A person licensed by the U.S. Coast Guard as a master of a vessel.
 - A person operating on a private lake or pond.
 - An operator who is accompanied onboard by a person who is least 18 years old and possesses the required Boating Safety Education Identification Card, provided that person is attendant to and responsible for the safe operation of the vessel.
 - An operator who is accompanied onboard by a person who is exempt from the educational requirements, provided that person is attendant to and responsible for the safe operation of the vessel.
 - A non-resident who has in his or her possession proof that he or she has completed a NASBLA-approved boater safety course or equivalency examination from another state.
 - A person who is operating a vessel within 90 days after the purchase of that vessel, provided they have available for inspection aboard that vessel, a bill of sale meeting all the requirements as established in Chapter 328.46(1), Florida Statutes.
 - A person operating a vessel within 90 days after completing an approved boating safety course, as required in Chapter 327.395 (1), and has a photographic I.D. and a boater education course completion certificate showing proof of having completed the required boating safety education course. HERNANDO COUNTY SHERIFF'S OFFICE CARE LINE

The Hernando County Sheriff's Office has established a program for the security and wellbeing of those people living alone who would like daily contact with someone who cares.

To participate in this program, you can request an application from the Hernando County Sheriff's Office, (352) 797-3660.

The application, properly completed, is also an agreement to comply with procedures essential to make the program successful. A waiver is included which, when signed, authorizes a Deputy to enter your residence to check on your well-being, should that become necessary.

In the event we do not receive a call from you, a CARE LINE representative will attempt to call you.

If we do not make contact, we will then check with the neighbor/friend you listed on your appli-

cation. If this fails, a Deputy will be dispatched to your home to check on your well-being.

Our primary concern is to make certain you have not suffered some injury or illness that prevented a response to our call.

When you enroll with Care Line:

1. You must call the Care Line Office at (352) 797 - 3799 every morning between the hours of 6:00 a.m. - 9:30 a.m.
2. If you are having a medical problem, please state this when you call.
3. If you plan to be away from home for any period of time and will be unavailable that day (or any number of days), you should notify the Care Line prior to your departure and again upon your return home.
4. We ask that you include the names and phone numbers of neighbors or someone locally that would be aware of your daily activities. We would like the name and number of a relative to contact in case of an emergency, even if they live out of

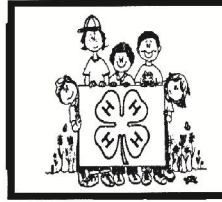
