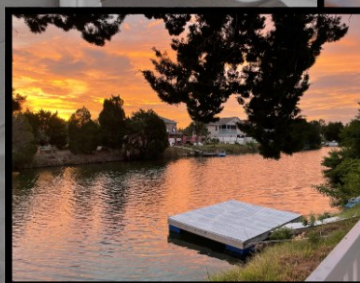

Lots happening in Hernando County Government these days. At the time of the receipt of this Beachcomber, our Board of County Commissioners will have approved the 2026 operating budget which starts on October 1st, 2025. That means in practical terms tax statements will start to arrive sometime in October for payment beginning in November, 2025. New is a \$15 per trip, convenience center fee starting on January 1st, 2026, credit card only, I am told. I drove past the vehicle staging lot for the Coastal Refuse Collection Company recently. All the trucks are shiny and new, in preparation for the Republic contract terminating. I am told that the effective date for that will also be January 1st, 2026? As it relates to the observation tower in the Linda Peterson park, the tower currently is scheduled for demolition based upon the recommendation by a structural engineer as not repairable. Our BOCC however has committed to constructing another tower. Funding ideas are being investigated, to include issuing a bond to pay for the expense and maybe having parking fees at that location. As it relates to the repair of Caliente Street and the boat ramp area. Speaking to our County Engineer, in the next 60 days a "Soft Start" notice will be provided to the successful contractor to begin to acquire materials to include piping for drainage. Following that, a construction notice to proceed will be issued. More to follow on this in the next couple of months, since this will involve traffic re-routing. Now for the Best News! Dennis Polyn, our Secretary and I met with our Director of Public Works recently at his location, and Hernando County has agreed in principle to take over the maintenance and utilities expenses for the Dolphin and Triangle properties. This is in compliance with the desires of our membership, to turn over financial and liability responsibility to Hernando County Government. Within the last 60 days we have had two reportable accidents at the Triangle property. In 2024, I know of at least 4 accidents that occurred at that location. Agreements still need to be signed, but in October the ratification by our BOCC should take place in the form of a "Correspondence to Note" in the official county record. Our HBPOA only exists because of your generous patronage in the form of membership dues, our valued sponsors and your willingness to volunteer in order to better our community. October and November is the time we solicit for volunteers to accept leadership opportunities. The office of President and Vice President will be

### **Power Outages: Just Another Excuse for a Beach Bonfire & Tea Light Dinner**

Hernando County has been having power outages recently, but don't worry — dinner's not canceled, it's just candlelit when you use these tips and tricks! Cooking with tealights during a power outage may take a little creativity, but it warms more than just your food. Think of it as an adventure with ambiance — soups, snacks, and maybe even s'mores, all powered by tiny flames that turn your kitchen into a cozy little bistro.

### **Stay Safe, Stay Full, and Let the Tealights Shine On!**

#### **1. Improvised Candle Stove**

- Place 4–10 tea lights under a metal rack, small grate, or cooling rack.
- Put a small pot, pan, or tin cup on top of the rack
- Tip: To conduct more heat at a quicker pace, wrap the rack with aluminum foil
- Works for: heating soup, boiling small amounts of water, warming canned food and cooking cookies!

#### **2. Foil Packets**

- Wrap food (like sliced veggies, small meat strips, or beans) in foil packets.
- Place them on a rack above 6–12 tea lights.
- The foil helps distribute heat and cook more evenly.

#### **3. Slow Heat for Drinks**

- Use 2–4 tea lights under a mug on a trivet or metal stand.
- Perfect for keeping coffee, hot cocoa, tea, or broth warm.

#### **Foods That Work Best for the Tea Light Method**

- Canned soups, beans, chili, veggies, meat strips (just heat through).
- Ramen noodles (with boiled water).
- Oatmeal or rice (takes longer, use more candles).
- Foil-wrapped veggies or small quesadillas.
- Melted cheese or chocolate (like fondue).
- Cookie Dough (make sure to cook thoroughly to prevent eating raw eggs).

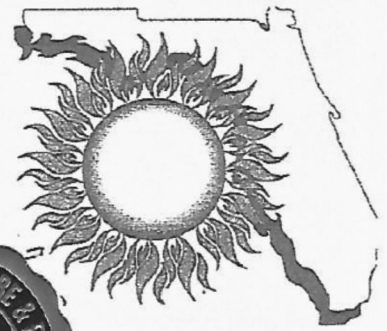

### Hernando Beach: Preparedness Is the Best Evacuation Plan

For many years, Hernando Beach has been fortunate to avoid a direct strike from a major hurricane. This history has led some residents to remain at home during evacuation orders, believing storms would once again "just miss" our coastal community. That perception changed in 2024 with Hurricane Helene, a storm that proved how quickly conditions can escalate and how vulnera-

ble Hernando Beach and the county's coastline truly are.

As we enter the peak of hurricane season, Hernando County Emergency Management urges all Hernando Beach residents to take preparedness seriously and consider the following measures to better prepare for potential impact.

### Know Your Home, Know Your Zone

Every resident of Hernando Beach lives in **Evacuation Zone A**, the area at greatest risk from storm surge. This means that if an evacuation order is issued, you should not plan to stay. Storm surge can rise quickly, cutting off roads and flooding homes within hours.

Beyond knowing your zone, it is equally important to understand the strengths and weaknesses of your home. Is it elevated on stilts or built at ground level? Does it have hurricane shutters or impact-rated windows? How old is the roof, and was it built to current wind standards?

Even if your home is more wind-resistant, **no home in Hernando Beach is safe from significant storm surge**. For that reason, evacuation is always the safest option when orders are given. Still, by knowing your home's vulnerabilities, you can take steps to secure it before leaving—such as reinforcing entry points, protecting windows, and safeguarding valuables.

### Home Safety Checklist Before You Evacuate

- **Shut off main breakers and non-essential utilities** before leaving to reduce the risk of electrical fires and damage.
- **Relocate items powered by lithium-ion batteries**—such as electric vehicles, golf carts, scooters, and other rechargeable equipment—whenever possible. If relocation isn't possible, move them to higher ground and disconnect from chargers.
- Secure windows, doors, and outdoor furniture.
- Elevate important documents and valuables.

Avoid relying on rumors or unverified social media posts—accurate and timely information saves lives.

## Stay Connected with Alert Hernando

One of the best ways to stay informed is by enrolling in **Alert Hernando**, the County's official emergency notification system. This free service delivers emergency alerts—including evacuation notices, severe weather warnings, and road closures—straight to your phone, email, or text. Signing up today ensures you won't miss critical information when every minute counts.

## Be Ready to Leave Quickly

When evacuation orders are issued, time is limited. Having a disaster supply kit and a "go bag" prepared in advance is essential. Include water, non-perishable food, medications, important doc-

uments, flashlights, batteries, and supplies for pets. Being ready ahead of time will reduce stress and help you move quickly when it matters most.

Hurricane Helene showed us that Hernando Beach is not immune to the dangers of storm surge and high winds. Preparedness is not just about protecting property—it is about protecting lives.
