not homesteaded, January 2026 is the deadline for the 2026 tax bill, which will be payable in 2027. We pay always one year behind. There is a difference between assessed value which includes homestead and other discounts versus the appraised value. Florida determines appraised value annually based upon Hernando County real estate sales. Also, the Board of County Commissioners has the disposition of the Triangle and Dolphin Gateway properties on their agenda for the December 16th Board Meeting. Their deliberations are live cast and can be linked to using the "Hernando County Meeting Portal".

I personally would like to thank the membership and the 2025 HBPOA Board for having provided me the opportunity to lead our association this past year. This joint effort project will improve area drainage, utility infrastructure, and roadway safety. The project also includes the realignment of Flamingo Boulevard to Shoal Line Boulevard and the removal of Petit Lane. Construction is expected to last approximately 10 months. During this time, motorists should expect periodic delays, but roads will remain open to thru traffic throughout the duration of the project.
