Dear Mr. [REDACTED]

This letter is provided to you, with an attached Motion for Sanctions, pursuant to F.S. 57.105, directed at Defendant's Motion for Temporary Injunction. Your motion contains numerous factual inaccuracies and is not supported by the law applicable to facts recounted in the motion.

The appended Motion for Sanctions has not been filed. However, if your motion is not withdrawn within 21 days of service of this letter, the attached Motion for Sanctions will be filed in accordance with F.S. 57.105. In that event, I will be retaining counsel to contest the motion at the upcoming hearing in October and will seek an award of attorney's fees and costs incurred in resisting the motion.

The Motion for Injunction is flawed in many critical aspects. The motion once again accuses me of stalking [REDACTED] an employee of Soho House. In fact, as you are well aware, [REDACTED] brought claims of stalking against me in a separate action seeking injunctive relief for alleged stalking. Her claims were so frivolous that Soho House declined to provide her with legal representation. I was compelled to obtain counsel and her claims were the subject of a trial in circuit court. At the conclusion of an evidentiary hearing, the Court found no probable cause and dismissed her Petition for Injunction. Nonetheless, you have realleged [REDACTED]'s discredited claims of stalking in support of your motion for injunctive relief. To the extent that the motion is based on those dismissed claims, relief is barred by the doctrine of collateral estoppel, having been considered in a prior legal proceeding adversely to [REDACTED]. The allegations contained in your motion.

Your Motion for Injunction is also flawed as it seeks to enjoin my communications with individuals and parties who are not litigants in the pending litigation. In effect you are seeking to enjoin my communication with third parties, in violation of my constitutional rights of speech and free association. You claim irreparable harm, when any third party with whom I may wish to communicate may simply refuse my calls (if any) or discard or otherwise ignore communications which I might generate. Should my communications cross a line, i.e. involve defamation or other tortious behavior, you have adequate legal relief available for slander, libel or tortious interference with business relationships. There is no justification for impingement on my constitutional rights or your attempts to muzzle my communication with third parties regarding the course of conduct of your client.

In regard to your allegation of trespass, I have rarely visited the public restaurant of the Soho House. In any event that establishment holds itself out as a public accommodation open to the public. I am a member of the public. Denial of access to public accommodations again raises issues of constitutional

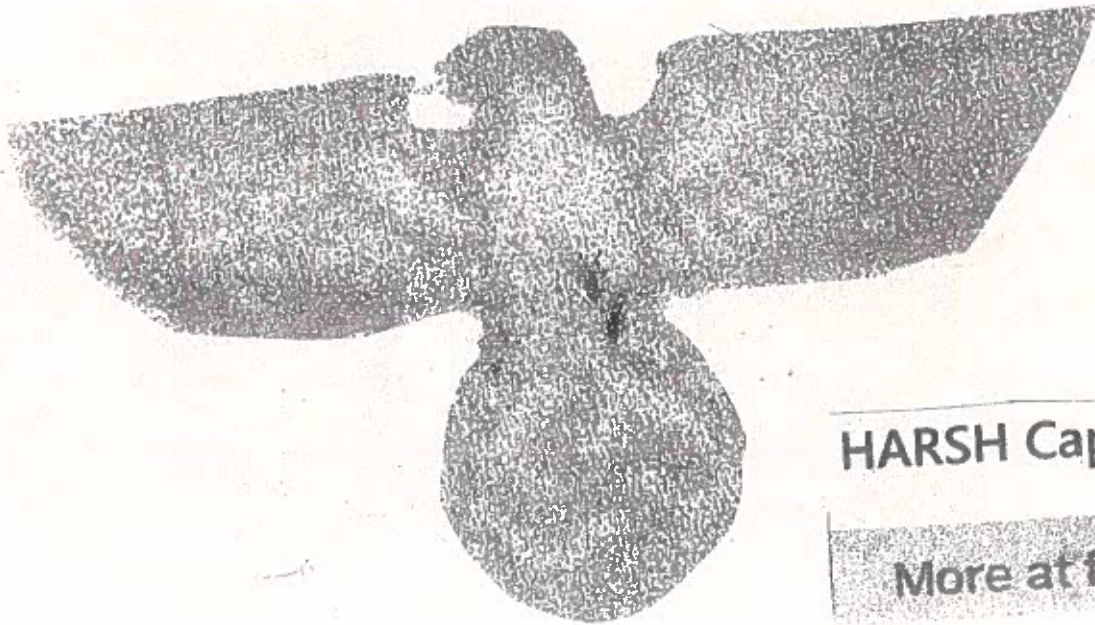

The recommended ways to kill a horse are by firearm or lethal injection. If you choose to use a firearm, the preferred method is by a rifle shot using the frontal method. The ideal site is slightly above (1cm) the intersection of two imaginary lines drawn from the eye to the opposite ear.

For adult horses – a rifle should deliver at least the muzzle energy of a standard 0.22 magnum cartridge.
For foals – a rifle should deliver at least the muzzle energy of a standard 0.22 long rifle cartridge.
