Dear Marcia,

As discussed I am seeking a briefing from the Crime Commission and AFP Commissioners ASAP. The senior advisory group should have the opportunity to speak to them. For my safety I am seeking a private meeting so I may speak frankly about matters subject to investigations involving leaders of the Uluru Statement movement. I am concerned about organised crime networks operating in Aboriginal communities and often run by leaders of powerful Aboriginal community organisations.

Unless this abuse of power is addressed, the voice process cannot work and I will not be able to support it.

There is a risk the voice may give more power for criminals and increase their cult like behaviour. Informing the community the government hates them and no one cares about them is being used to silence communities. The continued distribution of large quantities of the drug ice and the support given to abusers of children is not acceptable.

I have considered possible solutions and wish to test them against the formal operational advice we receive.
