A. Current Events

1. DCAD SFY 2023 Updates

Mrs. Ramirez touches on Division of Community Action and Development (DCAD) and the changes with the LIHEAP program starting October 1, 2022. The LIHEAP portal workflow presented to Board. LIWAP (Low-Income Water Assistance Program) is also discussed.

Mrs. Ross asks about Mail-In Applications and availability for the clients.

Mrs. Ramirez states as long as DCAD allows it SEACAP will have it available online and in-person.

2. Healthy Homes Program Update

SEACAP is in progress with this grant in Graham County and with Mariposa Community Health in Santa Cruz County. The program is on a referral basis with income-based qualifications. With success SEACAP may spend \$25,000-\$30,000 for abatement/replacement/repair for each home's air quality.

3. Home Rehab Program Update

SEACAP is currently waiting on ADOH (Arizona Department of Housing) to approve homes to begin the program. Five homes were approved for this program.

Mrs. Ramirez talks about the HAF (Homeowner's Assistance Fund) program that was introduced to the state. ADOH is waiting for SEACAP to complete the application to start a partnership for this grant. Approximately \$30 Million is still available to fund this program.

She gives details of the conferences case managers attending conferences (CAPLAW, NCAP).

Mrs. Ramirez explains that health insurance for employees increased approximately \$2600.00 per month for staff.

Organizational Standards were submitted with 4 items needing additional information. Needs Assessment and Strategic Planning are two items will be addressed in the coming year.

Invitation extended to SEACAP Board of Directors to WILDFIRE Annual Conference in Maricopa October 13 & 14, 2022.

CSFP distribution from SEACAP office for last fiscal year was approximately 32,000 pounds of food.
