December 7, 2019 – Assisted staff and Nogales High School students in the assembly of 57 bikes to be distributed at the Rio Rico Head Start Program. Also participated in the Willcox Christmas Parade, with staff, to promote the Census 2020.

December 13, 2019 – Participated, along with staff, in the distribution of the 57 bikes to the students who attend the Rio Rico Head Start Program.

January 8-10, 2020 – Attended the Community Action Partnership Management & Leadership Training Conference. This conference addressed intensive training, structured roundtable discussions and networking opportunities. Attended a variety of workshops with key session topics that included Economic Development, Racial Equity, Disaster Relief and Preparedness, Weatherization Leveraged Partnerships, Census 2020 and Community Level Impact to name a few.

January 18, 2020 – Participated in the 2020 Women's Expo Fair in Clifton promoting SEACAP services and the importance of Census 2020.

January 28, 2020 – Co-hosted the Federal Communication Commission (FCC) workshop presented at the Benson Library. The goal of this workshop was to expand outreach to consumers in rural areas and underserved communities, to provide consumer information and resources on telecommunication issues that affect their daily lives, as well as provide warnings and alerts on recent scams which have cost consumers millions of dollars.
