- 10. Superintendent/Secondary Principal Report: Andrea Knack mentioned our current enrollment numbers are at 206 students. MAPS administration went back so we are just now getting record requests, so those numbers can change. The budget is set for 200 students. There has been a ton of work being done on the building. Roofers have visited several times due to leaks, but haven't been able to locate leaks. They are unsure of the next move. They did have a full security assessment with different recommendations, such as shatterproof film for the glass doors and stop signs for the entryway of the parking lot. They are working on a quote for a PA speaker for outside and plan on getting an aerial view of school grounds to make a map. This will be used for local law enforcement to make a grid so they can be most effective in an emergency. Andrea reported lots of hauling furniture and junk. Lots of cleaning and decluttering and improving the buildings with replacing ceiling tiles and waxing floors. The first contracted day for teachers is Monday.
- 11. **NMU Charter School Office report**: Betty LaPointe mentioned it is quiet on the NMU CSO side of things. They will be doing a staff retreat in Mt. Pleasant in October. NWEA will do a one-hour overview at the retreat. It will be interesting and informative. Andrea mentioned a conflict for us to be able to attend.
