How It Works

- Your monthly membership price will be automatically drafted from you debit or credit card each month, entitling you to a single "Any 60,90, or 120 Minute Session" of your choice each month, on or after your scheduled payment date.
- You may upgrade to a longer session at additional charge.
- You may also share these memberships with one additional member; for example if you can't get a massage this month you can gift it to another person.
- If you do not use your session for that month, you will lose it.
- The membership monthly fee is specified on the application above. As long as your membership monthly payment is made you will be considered an active member in good standing.

Members are entitled to the following:

1. Complimentary aromatherapy- all natural aromatherapy is included in EVERY service
2. 50%off nonmember prices- Save 50%off all non member prices on any additional services and enhancements
3. Customizable services-personalize every detail of your session including time, aromatherapy, pressure, focus and even service enhancements
4. No upcharge for customized treatments-no additional cost for Swedish, sports, prenatal, any personalized massage
5. Flexible and priority scheduling – example: a member can split a 60 minute massage into 30 minute massages
6. One cancellation fee (if notice is less than 24 hours prior to scheduled appointment) waived per year.

MEMBERSHIP TERMS & CONDITIONS:

____(Initial) This membership and services purchased under this membership are non-transferable to any other person or entity.

____(Initial) For purposes of identification and billing, you agree to provide us with current, accurate, complete and updated information including your name, address, telephone number and applicable payment data. You agree to notify us promptly of any changes.

____(Initial) The Spa reserves the right to revoke membership at any time for misconduct on our premises. The Member will be responsible for payment in full upon revocation of membership.

____(Initial) The Spa reserves the right to change pricing at any time upon reasonable notice. Should prices increase, the Member have the right to cancel membership without penalty during initial period following cancellation guidelines as described below.

CANCELLING YOUR APPOINTMENT:

____(Initial) You may cancel your appointment without charge if you cancel **within 24 hours** of your appointment. Cancellations without 24 hour notice may result in a **\$25.00 charge** for your session, as that time has been set aside specifically for you. No shows may result in a full charge for that session.

CANCELLATION OF MEMBERSHIP:

____(Initial) This Membership Agreement may be cancelled, at any time, by providing written notice of cancellation no less than **30** days prior to the desired cancellation date. No refunds shall be due for any service available or rendered prior to written date of notice of cancellation from Member. If you do not wish for this Membership Agreement to automatically renew, you must provide written notice of cancellation no less than thirty **(30)** days prior to conclusion of the then-current Membership Term.

____(Initial) Contracted membership services will be forfeited at time of cancellation effective date.

_____ (Initial) Spa Amore reserves the right to terminate or deny re-enrollment for an indeterminate amount of time if you have an unsatisfactory payment history.

PAYMENTS DUE UNDER MEMBERSHIP AGREEMENT: Payment will be processed on the first (1st) day of each month on Membership. I hereby authorize my bank / financial institution / credit card lender to make payments from my checking, savings, debit and/or credit card(s) account on pre authorized drafts and / or charges drawn by **Spa Amore, LLC ("the Spa")**, and post them to my account. I further acknowledge my payment obligations as set forth in this membership agreement. I, by my signature below and by my use of the facilities, confirm my acceptance of all conditions herein. All payments due hereunder will be collected by Electronic Funds Transfer ("EFT") via a valid debit or credit card which Member shall keep on file with the Spa. I acknowledge all payments will be processed on the first day of each month and it is my responsibility to maintain valid and current card / payment information to the Spa. I agree that my failure to maintain valid and current card / payment information will constitute a default of this Membership Agreement.

TERMS OF MEMBERSHIP AND AUTOMATIC RENEWAL: The Membership Term for this Membership Agreement is MONTH TO MONTH, beginning the first day of the first month following the date on which this Membership Agreement is signed by Member. Unless otherwise cancelled in accordance with the terms of this Membership Agreement, THIS MEMBERSHIP AGREEMENT WILL AUTOMATICALLY RENEW AT THE FIRST DAY OF EVERY MONTH. If you do not wish for this membership agreement to automatically renew, you must provide written notice of cancellation no less than thirty (30) days prior to end of the then-current Membership Term. All memberships renew at the sole discretion of SPA AMORE, LLC, which reserves the right to cancel this Membership Agreement at any time and to refuse to renew this Membership Agreement with Member.

ACCELERATION OF PAYMENTS: If you are in default of this Membership Agreement, Seller can immediately and without notice, demand payment in full of all unpaid installment(s) and applicable fees.

DISHONORED INSTRUMENT / DECLINED EFT FEE: If an automatic debit or electronic funds transfer for the payment of the money drawn on any bank, depository, or credit card submitted by you is not honored or declined, then a fee will be added per the following, in addition to any unpaid balance of this Membership Agreement: (A) A fee of no less than \$35.00, which fee is subject to change at Seller's sole discretion; (B) The amount allowed by state law; or (c) The amount equal to the actual fee imposed by Seller's payment processing provider as a result of Member's dishonored instrument or declined EFT.
