"[T]he presence in person or of proxies entitled to cast sixty (60%) percent of all the votes will constitute a quorum. In the event the required quorum is not present at such meeting, another meeting may be called upon notice as set forth herein, and the required quorum at such subsequent meeting will be fifty (50%) percent of the required quorum at the preceding meeting."

Voting will be by secret ballot, unless a nomination is made orally. Each homeowner (1 vote per lot) will be given a tear-off sheet with the names of all candidates, and extra sheet for write-in.

Two votes for two separate candidates will be cast by each homeowner. The top-2 vote getters will be elected to the Board, with the top vote getter taking the longer term.
