Users are asked to leave the facilities clean and remove any waste or equipment used.
7. **Water Quality in the Lap Pool:**
The water in the lap pool is sourced directly from Black River and is pumped into the pool. Due to this, the water may appear discoloured. We do our best to maintain water quality by refilling the pool and allowing the water level to decrease before adding fresh water from the pump. This process may cause the water to look discoloured at times; however, it is safe for use.

The Owner agrees that horses are kept at their own risk.

The Agistor will take reasonable care but is not liable for illness, injury or loss. The owner is responsible for any damage caused by their horse.

BIOSECURITY & PROPERTY RULES
